## SoP for Direct Empanelment of Agency under State Funded Scheme ELSTP (Amended)

This notification supersedes the previous notification(s) regarding Standards of Procedures (SoP) for Direct Empanelment dated 23/01/2019 and 27/05/2019 vide S.No.RSLDC/Admin/Skills/2018-19/14647-14653 and S.No.RSLDC/ELSTP/SOP-Dir.Emp/2019-20/2191 respectively and is in accordance of the approval provided in the Board of Directors Meeting dated 2<sup>nd</sup> July 2020.

This SoP is formulated to set procedures of direct empanelment with aim to ensure early and easy initiation of skill training in the sector having potentials of wages/ self-employment. The SoP will be applicable for ELSTP scheme based on proposal falling under following conditions.

The window for such empanelment shall be available throughout the year.

Any such proposal received at RSLDC or invited with efforts of RSLDC will be examined by project appraisal committee in terms of eligibility and proposed courses & after recommendation, decision shall be taken by chairman RSLDC. Based on proposed course, project appraisal committee shall recommend along-with proposed conditions

If the project/proposal is approved, agency will be empaneled as PIA by signing the MoU with issuance of minimum initial targets. MoU shall be signed for a period of 2 years, which may be further extended for 1 year based on PIA's performance in the terms of training and placement. PIA shall execute as per applicable scheme guidelines & subsequent circulars/orders agency empaneled through this process will be exempted from EoI, however processing fee will be charged.
