

Skill Development & Livelihood

India has the world's largest youth population, with 354.4 million people aged between 15 and 29 years (India Labor Market Update, 2016, International Labor Organization – ILO). Despite the economic growth and an increase in general education levels, youth unemployment is a growing challenge, especially among the urban educated youth. Many families/youth migrating from the rural areas end up living in slum areas (low-income housing) and youth from these households lack access to the resources and opportunities to make a foray into formal sector employment.

The goal of "Skill Development & Livelihood" portfolio is to empower youth so that they are able to break the cycle of poverty and lead a life of dignity. The portfolio is further bifurcated in the following five subthemes-



- (i) **Yuvakendras:** Skill Development Centers help in reducing the gap between demand and supply of skilled manpower by providing training in skill development and skill upgradation. The Yuvakendras enhance the vocational skills of youth, by imparting placement-linked and market-oriented skill training with suitable wage/self-employment opportunities.
- (ii) **Women Empowerment:** Marginalized sections have a strong desire and capability to break the cycle of poverty. Social mobilization, building institutions and providing alternative income generation opportunities are critical. Facilitation of knowledge, handholding, skill building, access to credit, access to forward and backward market linkages, awareness of rights and entitlements and access to livelihood services stimulate this upward mobility.
- (iii) **Incubation of Social Enterprises/ Micro Entrepreneurs**: Facilitating, handholding and nurturing young women and men. Undertaking capacity building, providing seed money and working closely to bring about long term sustainable solutions.



- (iv) **Career Guidance & Counselling:** Providing quality career guidance to School/ College students coupled with technical training so as to open their horizon to various career choices and also make them placement ready.
- (v) **Strengthening Government Institutions**: Information deficit among school and college goers is common and is further magnified in Government institutional setup. This information asymmetry hinders them from effectively participating in the workforce. Providing career guidance and counselling to students of public schools will prove to be critical for their progress and development. Similarly, strengthening of Government institutions in the vocational space is also the need of the hour. The focus will be on providing resources to existing Government Industrial Training Institutes (ITIs), Polytechnics and Government Institutions which will revamp quality education and improved learning experience.

Since FY 2016-2017, a total of 41,622 youth have been trained under Skill Development & Livelihood portfolio.

PURPOSE OF THIS RfP:

HCL *Uday*'s success is drawn mainly from the 'convergence' model where NGOs, duty bearers, communities and HCL Foundation come together and work towards integrated community development. This project is now in scaling up phase in all cities, where HCL has a presence.

The purpose of this document is to Request for Proposals (RfPs) in line with the standards of HCL Foundation. Respondents are requested to submit their proposals on the basis of detailed instructions given below to set up high impact projects under the HCL Uday Program in the proposed locations using innovative and sustainable models in the given thematic areas.

SCOPE OF WORK:

The scope of work against which the proposals are invited are classified as per Skill Development & Livelihood Framework (see above figure). An NGO/ CSO/ not for profit organization can apply in one or more pillars i.e. (i) Skill Development Centers or Yuvakendras, (ii) Strengthening women collectives, (iii) Incubation of Social Enterprises/ Micro Entrepreneurs, (iv) Career Guidance & Counselling & (v) Strengthening of Government Institutions.

(i) Skill Development Centers or Yuvakendras

Below are the processes which are expected to be undertaken for establishing and operating a Yuvakendra.

- Pre Training Phase
 - Market research and assessment
 - Centre Set Up
 - Recruitment and Training



Centre and trade affiliation – Sector Skill Councils (SSC) – NSDC, NIOS or any other
 Government/ University affiliation

Training Phase

- Mobilization and counselling
- Batch screening and registration
- Trainee induction and classroom sessions theory and practical
- Employability skills life skills, personality development modules
- Spoken English, Financial Literacy and Basic IT
- o Regular assessments on both technical and life skills
- Exposure visits, OJT
- Mock Interviews

Post Training Phase

- Interviews and placement support
- Post placement follow up
- Employer feedback
- Facilitating and educating trainees to various government entitlements

The selected partners are expected to strategize depending on the local socio-economic context incorporating the above parameters. Placement of at least 85% of the batch is desired. *Projects pertaining to setting up Yuvakendras for Persons with Disability (PwDs), transgender, war widows and other such marginalized sections of the community are encouraged.*

Tentative target beneficiaries to be around 300 for a year, this is to be taken as a benchmark and can be modified.

(ii) Strengthening women collectives

Capacity building of community institutions like Self Help Groups, Cluster/ Block/ District Level Federations to be under taken. Below are the suggestive steps which needs to be taken -

- Mobilize women, primarily from poor households, into community groups or identification and strengthening of existing community institutions.
- Ensuring SHGs or Cluster/ Block/ District Level Federations follow NULM/ NRLM/ NABARD norms or any other well defined practices.
- Build linkages of target beneficiaries with economic activities either through skill training or provide avenues in entrepreneurship activities or forward/ backward market linkages.
- Building capacities of the community in financial literacy, adult literacy and other necessary and



relevant modules/ topics.

- Establishing community computer labs in slums for SHG women, their family members and community.
- Facilitating and educating SHG women to various government entitlements

The selected partners are expected to strategize depending on the local socio-economic context incorporating the above parameters.

Tentative target beneficiaries can be 25-30 SHGs or around 300 women for a year, this is to be taken as a benchmark and can be modified.

(iii) Incubation of Social Entrepreneurs/ Micro Enterprises

Some of the important parameters which needs to be considered are -

- An incubator that has an established model of delivery of 3 years or more in the space.
- A minimum of 20 Social Entrepreneurs must have been incubated in the last 3 years.
- The incubation support should be a yearlong.
- There should be at least 200 applications for every 10 Social Entrepreneurs selected.
- The selected Social Entrepreneur should be solving problems in the field of Livelihood, Education,
 Environment, Health, Sports or Gender equality.
- Incubator should have a robust selection process.
- In the first year of support -
 - 20% of the cohort should show 70% increase in their beneficiary
 - 20% of the cohort should show 70% increase in their organization spend/ funds raised/ revenue earned
- After 3 years, 70% of the cohort to build and scale their model

A cohort may incubate 5-30 Social Entrepreneurs, tentatively in a year. This is to be taken as a benchmark and can be modified.

(iv) Career Guidance & Counselling

Information deficit among school and college students is common and is further magnified in Government setup. This information asymmetry hinders them from effectively participating in the workforce. Providing quality career guidance to School/ College students coupled with technical training so as to open their horizon to various career choices and also make them placement ready. **Tentative target beneficiaries to be Schools/Colleges (preferably Government run/ aided).**



(v) Strengthening Government Institutions

Working with ITIs/ Polytechnics and other institutions providing Vocational Training to youth or providing Government scheme and entitlements linkages to underprivileged youth.

Location Details

HCL Uday has its presence in 11 cities of India. At present HCL Foundation is inviting proposals for Chennai and Nagpur locations.

Submission Details & Deadlines

Reputed NGOs/agencies may submit proposals as per their strength and area of expertise.

All proposals must be submitted as per 'HCL Uday' and as per the prescribed Proposal Format along with Annexure A (Budget) and Annexure B (Gantt Chart). All 3 formats can be downloaded from the link below: HCL F - Proposal Formats

Budget: Budget must be submitted as per the attached template. Please provide detailed break-up of each line item and all sub-line item costs with clear budget explanatory notes. Any taxes including Service Tax, Sales Tax, Value Added Tax or any other applicable tax, duty, cess or levies, must be quoted separately from the price of goods and services. The terms of payment along with a tentative timeline must also be attached.

Gantt Chart: The Gantt Chart must detail the comprehensive list of activities proposed in the proposal along with a tentative timeline. A sample Gantt Chart can be downloaded from the link above. NGOs/Implementation Agencies may make the required changes in the Gantt Chart as per the activities proposed by them.
