

The Bidder has to submit a Bid online in **two envelope systems**, one containing **Technical Bid** and other containing **Commercial Bid** for **Request for Proposal (RFP)** for **"Selection of Assessing Bodies For Sector Wise Assessments of Modular Employable Skill (MES)/NCVET/ MSCVT/ SSC Courses."** **Conducted By TRTI, Pune.** The Bidder can submit Bid online, provided that the Bidder can arrange adequate resources within 30 days of award of contract, to provide the said solution for which the Bid is submitted. Failure to arrange the resources, within 30 days, the award of the contract will be cancelled and the EMD will be forfeited.


4. Tender Fee (Non-Refundable)

The Bidders are requested to deposit the Tender Fee of Rs.20,000/- online. Proof of the same should be attached with the Technical Bid. It is to be noted that the Tender Fee is non-refundable. However, Tender Fee will be refunded in case of cancellation of overall tender process (i.e., if the tender process is cancelled by TRTI).

5. Earnest Money Deposit

The Earnest Money Deposit (EMD) of Rs.3,00,000/- is required to be deposited online. Proof of the same should be attached with the Technical Bid.

- The EMD shall be denominated in Indian Rupees only.
- No interest will be payable to the Bidder on the amount of the EMD.
- Bids submitted without adequate EMD is liable for rejection.
- EMD of unsuccessful Bidders will be refunded after completion of Bid.



- EMD shall be non-transferable.
- The EMD may be forfeited:
 - If a Bidder withdraws his Bid or revises/ increases his quoted prices during the period of Bidvalidity or its extended period, if any.
 - If successful Bidder fails to sign the Contract within the time specified by TRTI.



Section-3: Instructions to Bidders

1. BACKGROUND OF TRTI

TRTI PUNE is an autonomous institute promoted by the Tribal Development Department, Government of Maharashtra to act as the nodal agency for providing technical assistance and support in implementation (conceptualizing, planning, designing various schemes, programme and assist in implementation and monitoring of the projects and programmes) of various tribal development programmer of the Department. The TRTI PUNE functions as a technical support group having its existence at State level. TRTI PUNE has undertaken several initiatives to facilitate efficient delivery of market led training programs and skilling of youth. Thereby making them employable in the process. Towards this, credible Training Agencies are being invited to be engaged by TRTI PUNE for imparting Placement linked Skill Development training in different sectors for the youth of the State.

Funds for the implementation of different programs are transferred to the Tribal Research And Training Institute, Pune (TRTI) by the Tribal Development Department, Govt. of Maharashtra. As a supporting hand to the Tribal Development Department, TRTI PUNE manages fund flow to the various implementing agencies in the state of taking up different developmental activities.

Expression of interest is invited from eligible Training Agencies for empanelment under "Placement Linked Skill Development for the youth of the State in Maharashtra". Non NSDC or TDD/MSSDS partners, Industries and Educational and Professional Institutions will also be considered for imparting training under the said training programme.

2. REQUEST FOR PROPOSAL

TRTI requests for proposal from reputed organizations/consulting firms/ agencies to undertake "Empanelment of Assessment Bodies" as per scope defined in this RFP document.

3. SCOPE OF WORK

3.1 Affiliation of Assessment Bodies

A complete evidence based check of the documents, processes, methodology and availability of assessors will be carried out. The following needs to be undertaken with an aim to continuous upgradation of the process:

- a) Development of process, forms and formats, and a system of evidence capturing

- b) Development of list of details that needs to be delivered by an Assessment Bodies as per NSDC/DGET guidelines
- c) Assessors qualification/experience details required
- d) Quality Assurance
- e) Reporting to TRTI.

3.2 Monitoring

- a) Review assessment methodology
- b) Monitor compliance to the assigned tasks
- c) Periodically audit evaluation process.

4. METHODOLOGY AND REVIEW

4.1 Management and Methodology

The methodologies to be used must follow formal management practice to ensure adherence to schedule and scope. The AB should also include a methodology to ensure that TRTI, Pune is informed on an ongoing basis regarding progress/performance reporting, change requests, slippage, risks and issues, and a record of all activities carried out by the agency.

4.2 Review and Reporting

A system of reporting progress of activities will be developed and agreed upon with TRTI, PUNE.

5. GUIDELINES AND INSTRUCTIONS FOR ASSESSMENT AGENCIES

5.1 Eligibility Criteria of Assessment Bodies

- a) Company/Firm/Society/Trust fulfilling any of the following criteria may apply:
- b) Minimum 5 years of experience in the Skill Development sector
- c) Assessment Bodies/organization set up/affiliated by Government of India
- d) Assessment Bodies/organization affiliated to other Sector Skill Council.
- e) Should have Minimum Average Annual Turnover of Rs 3 Cr. From Assessment for F.Y 2018-19, 19-20, 20-21.
- f) Assessment Bodies/organization having strong IT infrastructure
- g) Assessment Bodies/organization having subject matter experts (for sector applied) on the company roles
- h) Assessment Bodies/organization having experience of conducting assessment in manufacturing sector

and should have assessed at least 50,000 trainees on yearly basis

- i) Minimum 100 assessors on company's role.

5.2 Pre-requisites for Assessment Bodies

a) Legal Existence:

- i. AB should be a legal entity (company or society but not firms, proprietorship or individuals; limited liability partnerships (LLPs) can be allowed)

b) Assessors Quality:

- i. AB should have a roll / panel of assessors for all sectors
- ii. Details of assessors should also be available on its website with state-wise details (assessors' name, qualifications, experience and photograph along with the details of assessor affiliations with multiple SSCs)

c) Assessment Process:

- i. AB should have an expertise to carry out online assessments with state-of-the-art technology deployment
- ii. The ABs should have the ability to develop the assessment process and tools for different training courses with ability for continuous improvement.
- iii. AB should have the ability to maintain assessment process records and details pertaining to candidates registered, tested, passed, centres, assessors, etc. and shall preserve all the records for at least 5 years or till the validity of any scheme (whichever is later) at any point in time and make its online access to SSCs

d) Geographic Spread:

- i. Assigned assessors should be able to reach the assessment venue within 24 hours of travel time and have the ability to conduct assessment in regional languages.

e) Organization Structure:

- i. AB should have a structured mechanism for Governance including a well-defined process for affiliation of assessors either on its payroll or on long-term contracts.
- ii. AB should have assessment coordination team on its payroll with required capacity and experience to mentor, supervise, plan the assessment strategy and to guide the team of assessors.
- iii. Conflict of Interest: It should declare its linkages with other stakeholders in skill ecosystem to ensure independence and to avoid any conflict of interest.

5.3. Prerequisites for Selection of Assessors

a) Qualifications & Experience:

- i. Assessor should possess relevant academic, occupational qualifications and work experience as defined in the QP.
- ii. Knowledge of assessment process and tools with ability to capture the assessment observations correctly on the prescribed electronic or paper forms.
- iii. Understanding of the Occupational Standards for the relevant QP is a must. Assessor must have the ability to plan each task and allocate necessary resources.
- iv. Understanding of competencies required in the job role for which assessment is being done with a high level of integrity, reliability and fairness.
- v. Good observation skills with ability to communicate in writing and orally in the local language in addition to English.
- vi. Ability to use technology viz, computers, tablets, spreadsheets, video communication tools.

b) Certified Assessor:

- i. Assessor must undergo necessary induction / orientation and certification under the TOA program through respective SSCs.

c). Assessors in Multiple Sector:

- i. Assessors undertaking multiple sector assessments must meet the qualifications for the relevant job roles and would need to furnish a self-declaration duly acknowledged by the AB.

5.4. Responsibilities of Assessment Bodies

- a) ABs should prepare question banks for each job role
- b) ABs should identify the assessor according to the needs of TRTI, PUNE
- c) ABs should provide logistics for the assessor
- d) ABs should follow the assessment protocol of TRTI, PUNE
- e) Ensure that the specified assessment guidelines are followed while conducting assessment
- f) Ascertain quality and transparency of assessment exercises, and abide by the stipulated timeline
- g) Store the copies of original assessment papers as per government guidelines
- h) ABs must accumulate photographic/video records of all assessments as per TRTI, PUNE guidelines

- i) ABs must provide the results of assessment along with the electronic form of the assessment sheets (physically and electronically) to TRTI, PUNE within ten working days of the completion of assessment. They should be able to furnish original hard copies if required by TRTI, PUNE.
- j) Collect additional information as may be specified by TRTI, PUNE

6. Information to be furnished by Assessment Bodies

- a) Details of the applying organization
- b) Details of prior exposure of the affiliating organization in skill development space
- c) Educational qualification and experience of the management team
- d) Suggested assessment methodology (ensuring innovative practices for stringent assessment process)
- e) Key achievements of the management team/project team in the area of skill development

6.1. Completeness of Response

- a) Assessment Bodies are advised to study all instructions, forms, terms, requirements and other information in the RFP documents carefully. Submission of the proposal should be done after careful study and examination of the RFP document with full understanding of its implications.
- b) The response to this RFP should be full and complete in all respects. Failure to furnish all information required by the RFP documents or submission of a proposal not substantially responsive to the RFP documents in every respect will be at the Assessment Bodies' risk and may result in rejection of its proposal.

7. Assessment Bodies' inquiries

- a) All enquiries/clarifications from the ABs related to this RFP must be directed e-mail before Pre-Bid

8. Submission of Responses to TRTI, PUNE

- a) The ABs should submit responses as per details given in RFP online.

9. Rights of TRTI, PUNE

9.1 Amendment or Supplement information to RFP

- a) At any time prior to the last date for receipt of proposals, TRTI, PUNE may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective proposer, modify the RFP document by an amendment.
- b) If TRTI, PUNE deems it appropriate to revise any part of this RFP or to issue additional data to clarify an interpretation of provisions of this RFP, it may issue supplements to this RFP. Any such corrigendum shall be deemed to be incorporated by this reference into this RFP.
- c) The amendment will be intimated to all proposers who confirm their intention to participate, by email.
- d) In order to afford prospective proposers reasonable time in which to take the amendment into account in preparing their proposals, TRTI, PUNE may, at its discretion, extend the last date for the receipt of proposals.
- e) TRTI, PUNE may, in exceptional circumstances and at its discretion, extend the deadline for submission of proposals by issuing a corrigendum through email to all confirmed proposers, in which case all rights and obligations of the proposers previously subjected to the original deadline will thereafter be subject to the deadline as extended.
- f) The proposers are allowed to resubmit their proposals if required, after such amendments.

9.2 TRTI, PUNE rights to terminate the process

- a) TRTI, PUNE may terminate the RFP process at any time and without assigning any reason. TRTI, PUNE makes no commitments, express or implied, that this process will result in a business transaction with anyone.
- b) This RFP does not constitute an offer by TRTI, PUNE. The proposer's participation in this process may result in TRTI, PUNE short listing the proposer and awarding the contract.

9.3 Short listing Criteria

- a) The evaluation committee of TRTI, PUNE consisting of experts would evaluate and select the successful proposer.
- b) Any attempt by a proposer to influence its proposal evaluation process may result in the rejection of the proposer's proposal.

The minimum qualifying marks required in technical criteria is 140 Marks (i.e., 70 %). The Bidders who score minimum 140 Marks shall be considered for Commercial Bid evaluation. The Bidders who do not score minimum qualifying marks of 70 %, their Bids shall be rejected and will not be considered for Commercial Bid evaluation. Total number of score should be equivalent to 100

B. Selection Method: Quality Cost Based System (QCBS)

The Bidder criteria for awarding the contract will be calculated based on the QCBS methodology.

The weightage of Technical Score to Financial Score would be in the ration of **80: 20**

Kindly refer the illustration below for understanding of the evaluation process

ILLUSTRATION

The following is the procedure for evaluation for the award of tender:

The technical and financial scores secured by each bidder will be added with weightage of 80:20 respectively and a Cumulative Bid Score arrived at, using the formula:

$$CS = TS * 0.8 + FS * 0.2$$

Where

CTFS is Combined Technical and Financial Score;

TS = Technical bid Score;

FS = Financial bid Score

The bidder with highest Combined Technical and Financial Score (CTFS) will be the successful bidder and be eligible to become the service provider

1. Award of contract
