Introduction

1.1 Contents of this RFP

1.1.1 This RFP comprises the Disclaimer set forth hereinabove, the contents as detailed below, and will additionally include any Addendum.

1.2 Background of Haryana Skill Development Mission

1.2.1 Haryana Skill Development Mission ("**HSDM**") was registered on 4th May, 2015 under the Haryana Registration & Regulations of Societies Act, 2012 to function as an autonomous organization under Department of Technical Education Haryana.

1.2.2 The primary objectives of HSDM are:

The Mission shall function as a non-profit, independent, and autonomous organization for implementation of skill development mission in the State. The mission shall have the following specific objectives: -

- (i) Increase employability of the youth and empower them to take part in the economic growth of Haryana and India, through skill training in modern and market driven professions at reasonable cost and monitoring its delivery, and thereby reducing unemployment, poverty and socio-economic inequality.
- (ii) To provide skill training to the students passing out from schools, school dropouts, Unemployed youth, Informal sector workers, Women and other disadvantaged groups.
- (iii) To inspect, monitor the quality of training imparted.
- (iv) To map demand for skill sets in the market and formulate programmes to meet such demand through high quality skill training.
- (v) Develop self-employment and entrepreneurial skills for youths of Haryana.
- (vi) To act as a platform for job seekers and provide assistance in getting self employment.
- (vii) To assist the State Government in formulating appropriate policy, legislations and/ or measures to fulfill the skill gap and constitute task forces for this purpose.
- (viii) To carry out or implement any other activities/ schemes which are beneficial to make the youth of State of Haryana employable.
- (ix) Assist in creating an enabling environment to attract investment in professional and skill development sector.

- (x) To undertake the capacity building programmes of various stakeholdersworking in the professional and skill development sector.
- (xi) To enter into any arrangement/ agreement with any person, company or association having similar objectives.
- **1.3 Objective of RFP** : To create a pool of Start Ups with innovative technology driven idea to cater/provide a scalable and viable solution & providing backward and forward market linkages to targeted sectors and upliftment of economic status and increase in livelihood of the Youth.

Organizations selected for empanelment pursuant to this RFP may be allocated work to impart skills training in Haryana after evaluating their proposal and technical presentation. Costing of sanctioned work shall be determined in accordance with the Common Norms notified by the Ministry of Skill Development and Entrepreneurship or as notified by HSDM from time to time.

1.4 Targeted Sectors:

Agriculture, Horticulture, Home-made Products, Educationists, Street vendors, Technicians, Handicrafts, Finance, Automotive, Beauty wellness, Solar and Renewable energies, Power, Environment, Entrepreneurship Development, Legal, accounting etc.

New Age Skilling Sectors viz. Electrical Vehicle, Drone Technologies, Artificial Technologies, Database Administration, Software Development, Robotics, Industry 4.0, Network administration, Manufacturing Technologies, AutoCAD etc.

1.5 Scope of Work

- Upskilling of Existing workforce i.e. RPL preferably Online Mode
- Entrepreneurship Development skill Trainings.
- To provide backward and forward linkage of Government schemes to increase the daily earnings/wages and financial assistance for ease of living/ease of doing small business/es
- Development of Digital course curriculum and LMS (No cost shall be borne by HSDM)

1.6 Eligibility -cum -Selection criteria:

- Any registered indigenous Start up entity having valid recognition certificate from Department of Industry and international trade (DPIIT), GoI
- The entity should not be loss making in last FY and at the time of application
- Entity should have ready Technological solution

- Entity with innovative Idea to outreach as large shall be preferred.
- Entities having ISO certification, patents etc. shall be preferred.

The eligible applicants as above shall be invited for presentation before selection committee on:

- Understanding of Skill Eco System
- Innovative idea to make outreach as large.
- Demonstration of ready technology driven solution
- Design and demonstration of Online learning Management System

1.7 General Terms of Empanelment

- 1.7.1 Applicant organizations must be eligible to apply for empanelment as per eligibility criteria mentioned in the RFP.
- 1.7.2 An Entity must submit a single application only to this RFP, otherwise the application shall be rejected.
- 1.7.3 Entities already empaneled with HSDM are not allowed to apply herewith.
- 1.7.4 Applicants not fulfilling the eligibility criteria as mentioned against each category shall be rejected not be evaluated further.
- 1.7.5 Based on application submitted by Applicant organizations in response to this RFP, HSDM will constitute a Panel of start-ups as Training providers, eligible for providing NSQF-aligned skill training to the youth.
- 1.7.6 The tenure of the empanelment shall be for a period of <u>01</u> year from the date of signing an agreement, with the empanelment status may be renewed for 1 year based on performance:
 - the TP continuing to meet the eligibility and qualifications criteria as required by the prevailing conditions for empanelment, or as may be amended by HSDM from time to time; and the performance of the TP under various skill schemes post empanelment process. At the time of empanelment renewal, documentary support for eligibility qualifications and credentials must be furnished to HSDM as requested.
- 1.7.7 HSDM, at its discretion, can modify or terminate the Panel earlier than the expiry of the <u>01(one)</u> year period in the event of change in law or due to other relevant reason(s).
- 1.7.8 HSDM, at its discretion, can terminate the empanelment of a TP earlier than the expiry of the <u>1</u>-year period in the event of failure of TP to remain eligible in view

of prevailing eligibility conditions (as revised from time to time) or to perform as per contract deliverables or other relevant reason(s) given in writing to the TP.

1.7.9 Empanelment with HSDM does not guarantee any form of income/ award of work/ retainer fees.

1.8 Description of Empanelment Process

- 1.8.1 Interested eligible organizations can participate in the Empanelment Process by submitting their application to the Mission. Each applicant organization must submit a single application for empanelment purpose.
- 1.8.2 Eligible Organization shall be considered for empanelment with HSDM and shall be invited for a proposal presentation before selection committee appointed by HSDM.
- 1.8.3 Along with the application, an applicant organization is required to deposit a **nonrefundable processing fee of Rs.5000/- (Rupees Five Thousand only) in form of demand draft in favor of Mission Director, HSDM payable at Panchkula.**
- 1.8.4 All the applicants are also required to submit the complete application/proposal in flash drive as well as in hard copy to mission.

Terms of Work:

1.8.6 After empanelment of TPs under the present Empanelment Process, work may be sanctioned to Empaneled TPs under skill programs of HSDM.

A. If work is sanctioned, Training Provider must comply to the Scheme Guidelines of SURYA or respective scheme or program and Monitoring Manual of Haryana Skill Development Mission for execution of the given work order by HSDM. These documents are available at <u>https://hsdm.org.in</u>. Any non-compliance shall lead to penalties as outlined in the above said documents. Payments by HSDM for works completed by Training Provider will be as per the terms and conditions stated in the afore mentioned documents and agreement with Training provider. Ideal batch size of 20 trainees is recommended for the training and shall not exceed 30 Trainees per batch and should not be less than 10 trainees per batch. Training Provider shall comply with instructions of HSDM regarding execution of the work order as may be issued from time to time.
