## 2. Need of Work:

Vocationalisation of Secondary Education in the Centrally Sponsored Scheme of Samagra Shiksha has been aligned with the National Skill Qualification Framework (NSQF) notified by the Ministry of Finance. Vocationalisation of Secondary Education refers to the inclusion of those practical subjects or courses, which shall generate among the students some basic knowledge, skills and disposition that prepare them to think of becoming skilled workers or entrepreneurs. It envisages the design, development, delivery, assessment and certification of skills content.

The Project Approval Board (PAB) of Samagra Shiksha, MoE has approved 90 Government schools of Tripura in the FY 2022-23 and implementation of the same will start from the Academic year 2023-24. The schools have already been identified by the State.

The vocational subjects are to be introduced as an Additional subject at the Secondary level and as Compulsory (elective) at the Senior Secondary level. The Project will adopt curriculum, course content and pedagogy, hire and train qualified teachers, introduce the program in schools, monitor and evaluate its progress, etc. as per the guidelines and norms of MoE-Gol. The curriculum and handbooks are already developed by PSSCIVE (PSS Central Institute for Vocational Education, Bhopal), based on the relevant Qualification Packs / National Occupational Standards of respective Sector Skill Council .

The Project shall include to provide educational services i.e. providing vocational trainers, supply of course material, supply of required software, awareness/publicity, counseling, set up of laboratories , supply of equipment and raw materials, maintenance of labs and equipment, Guest Lecture, hands on skill training/on-the job training, Assessment, organizing job fairs etc.

Accordingly, Samagra Shiksha, Tripura invites Tender from experienced, qualified Organizations having experience in the field of Vocational Education Program in Government Schools for implementation of the program in 90 approved Government schools (**Annexure-A**) in Tripura which may also be increased or decreased by 25%, subject to the availability of funds and performance of the bidder. (herein after referred as “The Project”).

## 3. Scope of Work, Schedule for work completion and Period of Assessment

### 3.1 Scope of Work

The Organization /VTP will be responsible for the following in the proposed program covering 90 Schools. The Vocational Training Providers are expected to:

- a) Provide resource persons including Vocational Trainer/teacher, Guest faculty etc. as per requirement of the project.
- b) Monitor the performance of the vocational teachers.
- c) Conduct Vocational teachers' training every year or as and when required by the authority of Samagra Shiksha, Tripura.
- d) Provide initially one (01) full time Vocational Trainer for each school and each sector and another trainer if required by the Samagra Shiksha, Tripura in the selected schools as per the Sector / Job Role.
- e) Understand the Curriculum and Course content prepared by PSSCIVE and ensure its delivery through its Vocational Trainers/Teachers, within stipulated time and meet the quality parameters.
- f) Complete the syllabus as per the time line.
- g) Provide awareness in the spirit of the NSQF program, ensure mobilization of students, parents, teachers and community awareness and provide guidance in consultation with Head Teacher of the schools.
- h) Ensure conduct of theoretical & practical classes as per NSQF guidelines.
- i) Ensure conduct internal assessment of the students with the help of HMs of school / Nodal In-charge of Vocational Education of the schools.
- j) Arrange industry visits/Hands on Skill Training to the student for their improvement in practical Exposure as per the norms of curriculum.
- k) Organize guest lectures in each class in each sector in each selected school.
- l) Supply the course material i.e. the Students and Teachers handbook and curriculum to the students of respective schools with different trades of VE in English or in Bengali as per requirement of Samagra Shiksha, Tripura.
- m) Conduct soft skill training including preparing the students for work as per the industry requirement.
- n) Provide consultancy support to Samagra Shiksha, Tripura for preparing proposal and reports regarding the scheme.
- o) Supply of VE Lab equipment (**as per Annexure-B,C,D,E,F,G,H & I**) and set up the laboratory with the required equipment for the proper delivery of the course content of different Trades in the respective classrooms which will be provided for the trades by the respective schools in coordination with Samagra Shiksha, Tripura.
- p) Providing Annual Maintenance Support for the supplied lab equipment.
- q) Implement the activities in this project as per the guideline of MoE or any other competent authority.
- r) Organizing job/career fair for generating employability of the passed out students (Class XII).
- s) Development of a dashboard/portal where the implementation of the project can be monitored including feedback on Project implementation, quality of classes etc.

- t) The selected bidder will have to set up one Project Office in the State located in Agartala and deployment of minimum one State Project Coordinator (administrative staff) and one technical staff having the following minimum qualification and job responsibilities within 1(one) month of receiving the Award of Contract with;

- u) Moreover, the selected bidder will also have to set up one help desk to provide technical and day to day assistance to the school Head Teachers / Vocational Teachers / School Education Department in terms of implementation of Vocational Education Program in the schools of the State.

### **3.2 Schedule for work completion**

The successful Bidder/VTP shall have to start preliminary works like appointment of Vocational Teachers, awareness generation, counseling, student enrolment, training etc. within 30 days as well as supply of lab equipment and setting up of labs within 90 days of receiving the Award of Contract.

### **3.3 Period of Assessment:**

After Award of Contract, under Recurring components the performance assessment may be conducted in every quarter for next 4 (four) years for each class through the representatives to be appointed by Samagra Shiksha, Tripura. The month of project considered as 'Go Live' shall be counted as first month.

Similarly, under Non-recurring head, the supplied lab equipment will be verified by the representative to be appointed by Samagra Shiksha, Tripura on submission of bills along with delivery challans duly signed by head of school.

## **4. Financial Provisions:**

The funding of the Project will be done through MoE, Government of India and Samagra Shiksha, Tripura. However Samagra Shiksha, Tripura will make payment for the same once for three months during the contract period based on the quoted Recurring cost after receiving bills duly supported document of satisfactory project implementation report from the District / school concerned.

### **4.1 Recurring Components**

**4.1.1 Financial support for one vocational teacher/trainer per job role:** Engagement and financial support of contractual vocational manpower by the VTP shall be **INR 20,000/-** per month per teacher/ trainer as per approval and provision of PAB, MoE, GoI. VTP shall mention the same amount in financial proposal.

**4.1.2 Provision for financial support for engaging resource persons:** VTP should arrange for engagement of guest faculty from the relevant Industry (Govt. or non-Govt.).

**4.1.3 Raw Materials, maintenance of tools:** The VTP should supply the adequate required raw materials for practical classes, study materials (books) for each student of VE and office stationeries (consumable items) for each course in schools for smooth functioning of the project as per norms and curriculum. The cost will include Annual Maintenance support for Lab equipment.

**4.1.4 Cost of providing Hands on Skill Training/Industry visit:** The VTP should arrange hands on skill training/industry visit for students enrolled under vocational education.

**4.1.5 Office Expenses/Contingencies:** The VTP should arrange for Office expenses (including expenditure on awareness & publicity, guidance and counseling, Staff conveyance, internet connectivity of schools, transport, school visits of VTPs etc.). Administrative cost for VTP is included under the component. No extra payment will be paid as an administrative cost.

**4.1.6 Induction Training of Vocational Teachers:** The VTP shall mandatorily arrange for conduct of induction training program for the manpower resources recruited by VTP. All trainings shall be arranged by the VTP in coordination with Samagra Shiksha, Tripura.

**Note:**

- Samagra Shiksha, Tripura will make payment once in three months during the contract period based on the quoted Recurring cost.
- Salary of the Vocational Teacher is fixed **as Rs. 20,000/- per month** during the contract period unless modified by Samagra Shiksha, Tripura.
- Recurring payment will be made for the component mentioned above. No extra payment will be made against work mentioned under Clause 3.1. Scope of Work.
- It shall be assumed that all these works/responsibilities mentioned under Clause 3.1. Scope of Work were accounted by the bidder while quoting financial Bid.

## 4.2 Non-Recurring Components

The VTP shall supply the items/equipments to the respective approved schools as per approval of PAB, Gol. The payment shall be made by Samagra Shiksha, Tripura on receipt of bills/invoices and submission of relevant documents certified by the official of Samagra Shiksha, Tripura after completion of lab equipment verification.

**N.B\*\*However all costs for the above Recurring & Non-Recurring Components shall be incurred by the VTP from the funds provided under recurring & non-recurring components and payment to the VTP shall be made within the approved rates and provision of PAB, MoE, Govt. of India time to time during the contract period. VTP should quote the amount for both Non-recurring and Recurring as per the format at Annexure - P.**

## 5. Penalty provisions

A committee may be constituted by Samagra Shiksha, School Education Department, Govt. of Tripura for reviewing the project progress on a monthly / quarterly / half-yearly / annually basis. The project period shall be 4 years from the date of deployment of manpower in the schools which will be considered as 'Go Live' of the project. After completion of the project period the contract shall be considered as expired until and unless renewed by both the parties on mutual consent.

**5.1 Implementation Period** - The project Implementation Period shall be as below-

- The VTP must be careful in maintaining the quality of work as well as adhering to the prescribed time schedule for the activity.
- If there is delay in course completion or lab set up or the performance is not satisfactory, then the Samagra Shiksha, Tripura reserves the right to invoke suitable penalty which may be forfeiture of the performance bank guarantee or as may be decided otherwise by the authority of Samagra Shiksha, Tripura.
- The successful Bidder/VTP shall have to start preliminary works like appointment of Vocational Teachers, awareness generation, counseling, student enrolment, training etc. within 30 days as well as supply of lab equipment and setting up of labs within 90 days of receiving the Award of Contract.
- The department shall be responsible for any delay in providing the site to bidder and in such cases penalty will not be applicable.

## 5.2 Service Level Agreement and Penalty clauses

The project Implementation Period shall be as below-

- If there is delay in lab set up or the performance is not satisfactory, then Samagra Shiksha, Tripura reserves the right to impose suitable penalty which may be forfeiture of the performance bank guarantee or as may be decided otherwise by the authority of Samagra Shiksha, Tripura.
- Delivery of all hardware equipment in 90 schools should be done within 90 days of issuing of work order. Penalty of Rs. 500 per day per Schools will be levied in case of delay in delivery of the items.
- Deployment of Vocational Teachers will have to be done within 30 days of issuing of work order. Penalty of Rs.200 per day per Schools will be levied in case of delay.

- In case of non-availability of Teaching facilitator for more than 1 week in continuation without prior permission of the School Authority, Rs. 200/- per person per day will be levied.
- The Bidder shall replace the Vocational Teacher if his/her performance is not found satisfactory consistently.
  - The Vocational Teacher will follow the academic calendar issued by the Education Department for teaching. Delay in executing teaching shall be treated as absence of Vocational Teacher and penalty shall be imposed on bidder.
  - The Vocational Teacher will not indulge in any activity that disrupts harmony of the school environment.
- In case the bidder is not able to set-up local project Office and posting of staffs within 1 (one) month of issuing the Award of Contract and subsequent submission of copy of Trade License/ Electricity Bill/ Telephone Bill for Office Set-up at Agartala and joining letters of Staffs as a documentary evidences, a penalty of Rs. 10,000 (Rupees Ten Thousand only) per week shall be applicable to the bidder.
- In case the bidder is not able to develop the dashboard / portal within 2 (two) months of issuing the Award of Contract a penalty of Rs. 5000/- (Rupees Five Thousand only) per week shall be applicable to the bidder.

- Any penalty may be revoked as decided by the authority of Samagra Shiksha on analyzing/examining the factual report.
- If at any time during performance of the Contract, the organization fails to maintain the prescribed time schedule then they should promptly notify in writing of the fact of the delay, it's likely duration and its cause(s). Within a reasonable time after receipt of the notice, the Samagra Shiksha, Tripura will evaluate the situation and may, at its discretion, extend the time for performance in which case the extension shall be ratified by the organization in writing.

### **INFORMATION TO BIDDERS ABOUT EVALUATION PROCESS**

- Consortiums bidding are not allowed.
- Eligibility criteria, Technical & Financial bids will be evaluated by the Tender Evaluation Committee to be formed for the purpose by Samagra Shiksha, School Education Department, Government of Tripura.
- The Tender Evaluation Committee shall evaluate the Proposals as per the response to the Bid and supporting documents/documentary evidence. Inability to submit requisite supporting documents/documentary evidence, the bid shall not be considered for evaluation and will be summarily rejected.
- Incomplete and conditional tenders will not be entertained. Bidder has to bid for all the sectors and job roles as referred to at clause 2.1 and for both recurring and non-recurring approvals. **In no case partial bidding will be accepted.**
- Bidders need to bid for all sectors and all schools for both Non-Recurring and Recurring components. **No partial bidding is allowed.** Requirements for different items in each sector against each school are specified in **Annexure- B,C,D,E,F,G,H & I.**
- The Tender Evaluation Committee may call upon any bidders for clarification on the statements and supporting documents/documentary evidence relating to the technical bid. The bidder has to furnish the clarification called for in writing within the stipulated time as fixed by the Tender Evaluation Committee. And in case of failure to do so the bidder may be considered disqualified.
- The Tender Evaluation Committee reserves the right to accept / reject any bid including the lowest bid (L1) received through GeM bidding process.
- The Comparative Statement to be displayed in the GeM portal page will not be final. The Bid Evaluation Committee will prepare an 'Evaluation Statement' considering all parameters as per conditions given in the bid document.
- The Tender Evaluation Committee reserves the right to reject any or all proposals on the basis of any deviations and the decision of the Committee in the matter of evaluation of the bids shall be final and abiding.
- The Tender Evaluation Committee reserves the right to relax any terms and condition in the Govt. interest, with the approval of competent authority.
- The Earnest Money Deposit (EMD) shall be forfeited if the successful Bidder does not accept the contract within given timeframe after getting the LOI or decided otherwise by the authority of Samagra Shiksha, Tripura.
- In case of any ambiguity, the decision taken by Bid Acceptance Authority on bids shall be final.

## **6. Evaluation process**

## 6.1 Eligibility /Pre-Qualification Criteria

The bidders are requested to provide all the documentary evidences for the below sub-clauses mentioned under Clause 6 in support of their eligibility. Non-compliance of any of the below sub-clauses will lead to rejection as non-responsive and as such will not be considered or the decision of the Buyer will be final.

- d) The Selection Committee of Samagra Shiksha, Tripura would evaluate the technical proposals on the date and time of opening of the proposals. The bidders are suggested to be ready for any information or queries posed by Committee through email or in presence.
- e) Bidders need to score **minimum 70% marks to be short listed** on the basis of technical evaluation process. This shall be called LIST-2.

## 7. Evaluation of Financial Proposal / Bids

- a) Financial proposals of only those bidders will be opened who are found in LIST-2 as per technical evaluation process. **The bidders will have to submit Rates, inclusive of all duties, taxes and other levies in INR as per format at Annexure – P.**
- b) Bidders need to bid for all sectors and all schools for both Non-Recurring and Recurring components. **No partial bidding is allowed.** Requirements for different items in each sector against each school are specified in **Annexure – B, C, D, E, F, G, H and I.**
- c) Bidders need to quote price for items as specified (in above referred annexure) for each sector on per school basis **against Non-Recurring Head and also for Recurring Head.**
- d) The total proposed amount under Non-Recurring and Recurring Head inclusive of any Annual Maintenance Charges & replacement charges of lab equipments and VE Classroom articles/ furniture/ infrastructure for next 4 (four) years i.e from 2023-24 to 2026-27 or up to contract period and all applicable taxes has to be within the approved fund of MoE, Gol.
- e) The financial proposals shall be based on the unit costs as prescribed in the Clauses 4.1 & 4.2 which will be subject to modification as per approval of PAB, Gol or by Samagra Shiksha, Tripura. The selection will be based on proposed cumulative cost (all Recurring & Non-recurring components) and work order will be issued for implementing in 90 schools as per sector and job role mentioned in clause 2.1 and within the fund limitation of PAB, approval, MoE, Govt. of India.
- f) The Work order / MoU / Agreement shall stand automatically modified in case of subsequent modification in the Gol scheme pattern and guidelines during the implementation period of contract for four years between Samagra Shiksha, Tripura and the successful bidder. Samagra Shiksha, Tripura will give intimation in writing for such modification, if any to the successful bidder for implementation of Contract as per the modified scheme norms and pattern.
- g) Samagra Shiksha, Tripura will deduct all applicable taxes as per rules.

## 8. Bidder Selection Process

- a) The final selection of successful bidder shall be made based on the lowest (L1) cumulative (all Recurring & Non-recurring component) rate quoted by the bidders.
- b) If same rate is quoted by more than one bidder, the technically highest scorer will be treated as L1 bidder or as decided by the competent authority of Samagra Shiksha, Tripura.
- c) In case L1 rates found to be unreasonable, then Samagra Shiksha, Tripura holds the right to award the work to the immediate most eligible bidder at justified rate.
- d) In case any single proposal received, Samagra Shiksha, Tripura has reserves the right to accept or reject the single proposal.
- e) Final selection for the implementation is the sole discretion of the Samagra Shiksha, Tripura.

## **9. Award of contract**

9.1 Samagra Shiksha, Tripura will notify the successful bidder after final selection. The successful bidder shall submit its acceptance in the GeM Portal as per the GeM Provision.

9.2 The contract period is to commence from the date of Award of Contract to the bidder and shall continue for next 4 (four) years, unless it is curtailed or terminated by the Samagra Shiksha, Tripura.

## **10. General Instructions**

### **10.1 Amendment of Bid Document**

At any time prior to the date of issuing Award of Contract, Samagra Shiksha, Tripura may, for any reason, whether at its own initiative or in response to clarifications requested by a Bidder, modify clause/s of the bid through the issuance of addendum/corrigendum. Addendum/corrigendum thus issued will be uploaded on GeM Portal.

In order to give the Bidders reasonable time in which to take an addendum/corrigendum into account, or for any other reason, the Samagra Shiksha, Tripura may, at its discretion, extend the bid submission date or bid validity.

### **10.2 Validity of Proposal**

The Proposal shall remain valid for a period not less than one hundred and eighty (180) days from the bid end date ("Offer Validity Period"). Samagra Shiksha, Tripura reserves the right to reject any Proposal that does not meet this requirement. Validity of Proposal may be extended for a specified additional period if decided by Samagra Shiksha, Tripura before the issuing date of Award of Contract. The Proposal Validity Period of the Successful Bidder shall be extended till the date of execution of the contract.

### **10.3 Language and Currency**

The Proposal and all related correspondence and documents shall be written in English language. If any supporting document attached to the bid is in any other language, the same may be



supported by an English translation and in case of any ambiguity the translation (original as translated by Samagra Shiksha, Tripura) shall prevail.

The currency for the purpose of the Proposal shall be Indian National Rupee (INR).

#### **10.4 Bidder's Responsibility**

It shall be deemed that prior to the submission of Proposal; the Bidder has made a complete and careful examination of:

- The requirements and other information set forth in this Tender document.
- The various aspects of the Project including, but not limited to the following: The Site, existing facilities and structures, access roads and public utilities in the vicinity of the scope;
- All other matters that might affect the Bidder's performance under the terms of this bid, including all legal obligations, clearances, risks, costs, liabilities and contingencies associated with the Project.
- It shall be assumed that all these factors were accounted for by the Bidder while quoting his Bid. The Bidder shall be deemed to have full knowledge of the site whether he inspects it or not.
- Bidders should upload readable documents (minimum 100 dpi) as well as in prescribed format. Unreadable and corrupt documents if uploaded may lead to cancellation of bids.

The Department shall not be liable for any mistake or error or neglect by the Bidder in respect of the above. Proposals that are not substantively responsive to the requirements of this bid document will be rejected.

#### **10.5 Disqualification**

Samagra Shiksha, Tripura may at its sole discretion and at any time during the evaluation of proposals, disqualify any bidder, if the bidder:

- a) Makes misleading or false representations in the forms, statements and attachments submitted as proof of the eligibility requirements which may be verified by the authority of Samagra Shiksha, Tripura.
- b) Exhibits a record of poor performance such as abandoning works, not properly completing the contractual obligations, makes inordinate delay in completion or financial failures, etc. in any project in the preceding three years.
- c) Submits proposals that are not accompanied by required documentation.
- d) The bidder should submit Technical compliance documentations for all vocational education lab equipment as specified in Annexure - **B, C, D, E, F, G, H and I** against which item specification is mentioned. Item specific brochure and website details of OEM need to be submitted for verification. Non-compliance of the same will summarily reject technical bid of the bidder.

#### **10.6. Termination**

Termination for Default: If the organization fails to carry out the award / work order/contract in terms of this document within the stipulated period or any extension thereof, as may be allowed by Samagra Shiksha, Tripura without any valid reasons acceptable to Samagra Shiksha, Tripura the contract may be terminated by giving two months' notice.

## **10.7 Disputes**

All disputes between the Successful Bidder and Samagra Shiksha, Tripura shall be settled as per the dispute resolution procedure elaborated in the Agreement and shall be governed in accordance with the laws of India and courts in Tripura State shall have exclusive jurisdiction to adjudicate disputes arising from the terms herein. During the bidding process no dispute of any type would be entertained. Even in such cases where Samagra Shiksha, Tripura asks for additional information from any Bidder, the same cannot be adduced as a reason for citing any dispute.

## **10.8 Governing Law**

The Bidding Process shall be governed by, and construed in accordance with, the laws of India and the Courts at Agartala, Tripura shall have exclusive jurisdiction over all disputes arising under, pursuant to and/or in connection with the Bidding Process.

## **10.9 Corrupt or Fraudulent Practices**

The Government requires that the bidders / Service Provider under Government financed contracts observe the highest standard of ethics during the procurement and execution of such contracts. In pursuance of this policy, the Government

- (a) Define for the purposes of the provision, the terms set forth below as follows:
  - (i) “Corrupt practices” means the offering, giving, receiving or soliciting of anything of value to influence the action of a Government official in procurement process or in contract execution: and
  - (ii) “Fraudulent practice” means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the Government and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the Government of the benefits of free and open competition.
- (b) will reject a proposal for award if it determines that the bidder recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question.
- (c) will blacklist / or debar an individual Service Provider /firm/organization, either indefinitely or for a stated period of time, if at any time determines that the firm has engaged in corrupt or fraudulent practices in competing for, or in executing a Government Contract.

## **10.10 Force Majeure**

The State Project Director, Samagra Shiksha, Tripura may consider relaxing the penalty and delivery requirements, as specified in this document, if and to the extent that, the delay in performance or other failure to perform its obligations under the contract is the result of a Force Majeure. Force Majeure is defined as an event of effect that cannot reasonably be anticipated such as acts of God (like earthquakes, floods, storms, pandemic etc.), acts of states, the direct

and indirect consequences of wars (declared or undeclared), hostilities, national emergencies, civil commotion and strikes at successful bidder's OEM premises.
