Dibrugarh University (DU) invited Expression of Interest (EoI) and Financial Proposal through <http://assamtenders.gov.in> portal from experienced/reputed Training Providers/Project Implementation Agencies for **selection/empanelment** as training provider/project implementation agency for providing Employability Enhancement Skill Development Training Program to the regular (on-campus)students of Dibrugarh University as an additional course outside their curriculum. The last date of submission of EoI with all relevant papers at the office of the undersigned is stated below.

The sealed Tender documents shall have to be duly superscribed as '*Expression for Interest for providing Employability Enhancement Skill Development Training Program at Dibrugarh University*' along with advertisement notice no. in capital letters on the top of the envelope. The intended bidders need to submit the financial bid as per the BoQ based on the details provided in Annexure – VIII (Phase I & II). The marking system in the QCBS method of evaluation and finalizing the bidder will be based on the annexures mentioned.

The whole draft is divided in to twenty two sections:

1. Background:

Dibrugarh University, one of the easternmost University in India, was established in the year 1965 consequent upon the provisions of the Dibrugarh University Act, 1965, enacted by the Assam Legislative Assembly. It is a leading research and innovation driven University that acts as a spatial slot to configure the socio-cultural dynamics of North East India. The University encourages myriad enterprises that harbour on a constellation of thinking, theorizing, and reflection.

Dibrugarh University is one of the educational centres of excellence, seeking to amalgamate multi-disciplinary fields with numerous theoretical perspectives, the realm of cultural diversity with the praxis of knowledge, and region-specific issues with a global horizon. The University has a prolific and productive industrial academia interface. With its strong global links in teaching and research programmes, the University offers dynamic educational experiences that prepare the next generation to lead and make a difference and thus contribute to the society at large. The University hosts 177 affiliated colleges and institutes that spread over nine districts of Assam. Dibrugarh University is a member of the Association of Indian Universities and is recognized by all the universities in India and abroad.

Dibrugarh University is situated at Rajabheta in the district Dibrugarh and it is five kilometres to the South of the Dibrugarh town. The University is well connected by road, rails, air and waterways and has a vast sprawling campus (550 acres) set in bucolic and idyllic surroundings.

2. Objective:

Expression of Interest (EOI) is an invitation to reputed and experienced Project Implementing Agencies (PIAs) for the implementation of Employability Enhancement Skill Development Training Programs in Dibrugarh University in alignment with the National Education Policy (NEP) 2020.

The objective of the EoI is to shortlist/empanel Project Implementation Agency as training provider to impart skill development training program to the regular UG/PG students (On Campus) of Dibrugarh University as an additional course outside their curriculum. The empaneled Project Implementing Agency (PIA) would impart knowledge to the students regarding the importance of critical skills such as in communication, soft skills, entrepreneurship, and technical proficiency which would enhance their employability and entrepreneurial potential, in line with NEP-2020's vision of holistic and multidisciplinary education.

On receiving of the tender documents, the Committee constituted for the said purpose would evaluate the tender documents to shortlist qualified Training Partners/Project Implementaton Agencies as per the eligibility criteria given in this EoI. After the completion of the EoI process for shortlisting, Dibrugarh University shall evaluate the Financial Proposal of only the shortlisted applicants. Interested applicants must also submit the Hard Copy of the EoI Proposal only to the office of the undersigned. Interested applicants are requested to read all the instructions and Terms and Conditions carefully before submission of the bids. Dibrugarh University reserves the right to amend the terms and conditions and cancel the same without any prior notification.

3. Scope of Work:

The selected Project Implementation Agency (PIA) would be required to carry out the following activities within stipulated timelines which shall be decided by Dibrugarh University.

The broad scope of work for Selected PIA is stated below. The detailed scope of work shall be incorporated into the Agreement signed between Dibrugarh University and the Selected PIA prior to execution of work. The intending Training Partner is required to provide the following services:

- a) During Batch Formation, PIA must do the prescreening of the regular students, enrolled in the UG/PG Program in consultation with Dibrugarh University.
- b) Post Batch Formation Career Counselling shall be done by the expert of PIA to set the right expectations of the students for the courses being offered.
- c) Training Centre Readiness in terms of setting up of digital classrooms & the labs with required equipment w. r. t. the Job Role/Course.
- d) Ensure the quality standards the related guidelines of Regulatory Body with regards to the training standards, infrastructure including the requirement of labs and workshops, qualifications of trainers and instructors' delivery of the course with the practical and proper assessment of the learning outcomes will be followed by the PIA.
- e) **Training:** - PIA must create a batch size of not more than 45 trainees for the conduct of Employability Enhancement Skill Development Training.
- f) **Assessments & Certification:** -
 - After completion of training, students would be assessed and certified as per the guideline of Certification of National Skill Development Corporation (NSDC) under Market Led /Fee Based Program.
 - The Project Implementation Agency should also conduct regular internal assessment in the form of quizzes, assignments and tests to develop learning habits among trainees.
- g) **Placement:** -
 - The PIA shall conduct regular Job Fairs for the students aligned with the skills delivered.
 - Employers from Assam and other parts of country shall be aligned by the selected PIA for providing skill/qualification based employment opportunity to the final year students of the university (as per Table no. 1).
- h) **Other conditions and general information:**
 - The PIA shall be responsible for all aspects of the training including centre readiness, quality of training delivery, assessment and certification, and outcomes required from the training.
 - Sufficient practical and on the job training/internship must be incorporated into the training module wherever necessary.
 - Any PIA/firm/company blacklisted/debarred by any Central / State Government/Dibrugarh University are not eligible to apply as Training partners.
 - During the inspection, if any violation of the prescribed norms is found or reported by the inspecting officer nominated by Dibrugarh University, penal action like revocation of targets, deduction shall be applicable.

- Selected bidder shall have to deposit the mentioned Security Deposit/Performance Guarantee amount in the form of Demand Draft/Banker's cheque/Fixed Deposit Receipt/Bank Guarantee in favour of Registrar, Dibrugarh University.
- The Technical Bid of all Bidders received in response to this EoI within due date and time shall be first opened for scrutinization with respect to its completeness and correctness. The bids which are complete in all respect and free from any material defect shall be scrutinized first to ascertain the eligibility as set out in Section-4. The bids which fulfill the eligibility criteria shall be subjected to further evaluation and technical scoring as per the parameter set out in Section-5.
- The financial bid of only technically qualified bidders shall be opened for evaluation.
- The bidding document with all information relating to the bidding process including eligibility criteria, evaluation and submission of bid, EMD, scope of the work and other terms and conditions is available in the e-Procurement Portal <https://assamtenders.gov.in> for download free of cost.

Note:

- The timelines as given above are subject to revision by the Authority of Dibrugarh University as per the emerging situation. Any changes in the timeline shall be communicated via the e-procurement portal and through university website.

4. Pre-bid Meeting

The Pre-bid meeting to discuss and clarify any issues related to tender provisions including terms and conditions shall be organized as per the details with respect to the date, time and venue as mentioned in the tender document. Prospective participants may also send their written queries, if any, at least one day prior to pre-bid meeting date via email du@dibru.ac.in.

5. Validity of the Bid:

- a) The Bid shall remain valid for a period not less than 180 days from the due date of its submission as specified in the tender document. A bid with a shorter validity period shall be rejected by the tender inviting authority as non-responsive.
- b) In exceptional circumstances, prior to expiry of the original time limit, the tender inviting authority may request the Bidders to extend the period of validity with mutual consent. The request and the Bidder's responses shall be made in writing or via email. A Bidder may refuse the request without forfeiting his/her Bid Security. The Bidder agreeing to the request will not be required or permitted to modify his/her bid but will be required to extend the validity of its Bid Security for a period of the extension, and in compliance with provisions relating to the Bid Security in all respects.

6. Signing and Submission of Bid:

- a) The Bidder shall prepare and submit the complete bid (both Technical and Financial) in the online portal within due date of submission.
- b) All documents that form part of the bid should be serially numbered, signed by the bidder on each page before scanning and uploading.
- c) Bid documents shall be typed and shall be signed by a person duly authorized to sign on behalf of the Bidder. All pages of the bid where entries or amendments have been made shall be initiated by the person or persons signing the Bid.
- d) The Bid shall contain no alterations or additions, except those to comply with instructions issued by the tender inviting authority, or as necessary to correct errors made by the Bidder, in which case such corrections shall be initiated by the person or persons signing the Bidder.
- e) Online Bids shall be digitally signed as per Class 3 digital certificate by a person or persons duly authorized to sign on behalf of the Bidder.
- f) The Bidder is required to submit the hardcopies of “Key Documents” within due date of submission as per tender terms and conditions. Key Documents, as follows, are required to be submitted in hardcopies.
 - i. Technical Bid Document
 - ii. EMD Receipt (if applicable)
 - iii. Declaration as per ANNEXURE-II
 - iv. Original Power of Attorney Document authorizing the signatory

7. Multiple Bids

- a) Each Bidder, shall submit only one bid in response to this tender. If a Bidder submits more than one bid, then all the bids submitted by it directly or indirectly shall be liable for rejection.
- b) There should not be a situation where two or more bidders have common ownership of more than 25%, either directly or along with close relatives. In such situation, it shall be treated as multiple bids by a single bidder and all such bids shall be liable for rejection.

8. Alternative Bids by Bidder

- a) The Bidder shall submit Bids (Technical and Financial) that fully comply with the requirements of the Bidding Documents. Conditional bids or alternative bids will not be considered further in the process of evaluation and will be deemed to be unresponsive.

9. Amendments or Changes in Bidding Document:

- a) Dibrugarh University may at any time before the deadline for submission of Bid, amend or modify

the provisions and other terms and condition as stipulated in the bidding document by issuing addenda or corrigendum.

10. Initial Eligibility and Qualification Criteria:

- a) To participate in this EoI, the bidder must be a single entity and having a formal intent and legal competency to enter into an agreement or contract and are registered under respective Act and Jurisdiction in India.
- b) Applicant must be recognized and Funded Training Partner of National Skill Development Corporation (NSDC).
- c) Applicant must have been registered and recognized by AICTE/UGC under Vocational Education / Skill Development Training Scheme as applicable.
- d) The Applicant must have imparted National Skills Qualifications Framework (NSQF) aligned Courses Training of minimum 10,000 (Ten Thousand) Candidates in the Past. (Work order needs to be submitted).
- e) The Applicant must showcase the minimum 02 nos. of Placement linked Skill Development Projects completed successfully and got the Payment of last tranche i.e. after achievement of Placement Milestone.
- f) The Applicant's Founder Promoter's Profile should have the following credentials:
 - a. Should have promoted Skill Development Training and/or VET Institutions.
 - b. Should have promoted Higher Education and Technical Education Institutions.
- g) The applicant must have executed at least one Single work Order of a Placement Linked Skill Training Project sponsored by any Central/State Govt. Institution worth Minimum Rs. 5.00 crore.
- h) The total turnover of applicant in the relevant field in last 03 Financial Years i.e. 2021-22, 2022-23 and 2023-24 must be more than Rs. 10.00 Crore. (the applicant who has not filed ITR for 2023-24 are not Eligible).
- i) One Single NSQF Based Skill Training Work Order in which number of trainees trained must be greater than 1000 and no. of trainees placed, post skill training and certification across all sectors must be minimum 40%.

11. The Technical Bid should contain the following:

The technical bid shall consist of documents to establish that the bidder fulfills all the eligibility criteria as set out in Section-10. The content of the technical bid shall include the documents given as below:

- (a) Covering Letter as per ANNEXURE-I, along with deposited EMD and Processing Fee receipts.
- (b) Declaration as per ANNEXURE-II (non-conviction and non-blacklisting)
- (c) Checklist for technical bid as per ANNEXURE-III.
- (d) PAN, TAN, Cancel Cheque, GST/Self-Declaration in case of Not Applicable.
- (e) The total turnover certificates through Skill Training in last 3 FY i.e. 2021-22, 2022-23 & 2023-24 must be more than Rs. 10 Crore. (The bidder who has not filed ITR for 2023-24 are not Eligible). Audited Balance Sheets of all the years along with CA Certificate having valid UDIN of the CA as per ANNEXURE-IV.
- (f) Details of the Manpower Provided ANNEXURE-V

- (g) Performance Statement as per ANNEXURE-VI
- (h) Details of EMD Deposited as per ANNEXURE-VII
- (i) Bidder's Profile as per ANNEXURE-IX
- (j) Incorporation Certificate along with Bylaws/MOA/AOA/ other documents.
- (k) Power of Attorney document/instrument in favour of the Authorised Signatory or the Board of Directors resolution (in case of Company) authorizing the signatory for signing the Bid as per ANNEXURE-X
- (l) Registration Certificate of Registered and Approved by AICTE/UGC/Skill India under Vocational Education / Skill Development Training Scheme.
- (m) Certificates and accreditations validated by NSDC with NSDC Partnership Certificates of All the Years including FY 2024-25.
- (n) Work Orders of imparted NSQF Aligned Courses Training in the Past along with Either Completion Certificate/ Govt. Portal Screen Shot.
- (o) Completion Certificate/ Payment proof of last Tranche of minimum 2 Placement-linked Skill Development Projects.
- (p) The bidder should submit the relevant documents of Founder Promoter's Profile with following credentials: -
 - i. Should have promoted Skill Development Training and/or VET Institutions.
 - ii. Should have promoted Higher Education & Technical Education Institutions.
- (q) One Single Work Order of Skill Training worth Rs. 5 CR. Along with Project Completion Certificate.

Note: Consortium/Joint Ventures will not be allowed.

12. Submission Process

- i) The Applicant must get registered with the e-Procurement portal www.assamtenders.gov.in using valid DSC for online submission of the EoI.
- ii) Interested eligible parties must submit their EoI online (scanned copy) on the e-Procurement portal within the due date and time of submission.
- iii) The EOI submission should be along with all documentary proof with respect to pre-qualification and other relevant documents while uploading online.
- iv) Each page of EOI (submissions) should be signed and stamped by the applicant or its representative. In case the proposal is signed by any one of the Directors or key officials (CEO, CFO or Company Secretary) a certified copy of the appropriate resolution / document conveying such authority may be enclosed. In case of partnership firm it should be signed by any one of the partner duly authorized by the partnership.
- v) The applicant is responsible for submission of EoI proposal complete in all respect. The authority of Dibrugarh University shall ignore the EoI in case of incomplete or defective submission.
- vi) Each page of the EOI submission should be serially numbered, signed and stamped by the authorized signatory and submitted on-line in the e-Procurement portal i.e. <http://assamtenders.gov.in>.
- vii) The Applicant must have to submit the Application in the form of proposal which must include all the required documents.

13. Evaluation Criteria:

(i) The applicant meeting the initial eligibility criteria will be further evaluated and shortlisted on the following parameters as per the indicated marks:

14. QCBS (Quality and Cost Based Selection)

The Applicant must achieve a minimum eligibility score of 50 out of 100 for the Financial Bid to be considered.

The Financial Bid will be evaluated on QCBS methodology in the ratio 70:30 i.e. 70% weightage will be given to the EoI Submission and 30% weightage will be given to the Financial Bid. The evaluation will consist of the following phases.

- i. Evaluation of Eligibility Criteria and Evaluation of EoI.
- ii. Evaluation of Financial bids.
- iii. Combined evaluation of EoI and Financial bids.

EoI Score calculation: The bidder with highest qualifying technical score (EoI₁) will be awarded 100% score. EoI Scores for other than EoI bidders will be evaluated using the following formula:

Normalized Technical Score of a Bidder (EoI_n)

Technical Score of the Bidder =----- Technical Score of EoI₁ X 100

Note: The score value is adjusted up to two decimal places.

Example: The bidder with the Highest EoI Score will be awarded 100 and other bidders will be awarded on percentile basis.

If the bidder with the highest EoI score is 90, then the EoI₁ bidder will get (EoI max)100. A bidder awarded 80 as EoI score will get (80/90) x100= 88.88.

Financial Score calculation: The bidder with the lowest qualifying financial bid (L1) will be awarded 100% score. Financial Scores for technically qualified bidders other than L1 bidders will be evaluated using the following formula:

Normalize Financial Score of a Bidder Commercial Bid of L1: =X100 Commercial Bid of the Bidder

Note: The score value is adjusted up to two decimal places.

Example: If F₁ is INR110 and F₂ is INR 120, then F₁ will receive (F_{max}) 100 and F₂ will receive [110/120]x 100= 91.67

Calculation of Composite Bid Score:

EoI and financial scores secured by each bidder will be added using weightage of 70% and 30% respectively to compute a Composite Bid Score.

The top bidder securing the highest Composite Bid Score shall be considered for the Empanelment.

The Composite Bid score will be calculated as follows:

$$B_n = (0.70 \times EoI_n) + (0.30 \times F_n)$$

EoI_n = Technical score of the bidder (out of maximum of 100 marks)

F_n = Financial score of the bidder (out of maximum of 100 marks)

B_n = Composite Bid score of the bidder

15. Training Pedagogy: -

The implementation of training will be in three phases. Employability Skills Training shall be offered to 1800-2000 no. of candidates during the **Phase-I** Training *i.e.* AY 2024-25 and bifurcation of modules shall be as mentioned below:

Digital Literacy : 80Hrs
Soft Skill : 30 Hrs.
Spoken English : 60 Hrs.
Employability Skills : 30 Hrs. **A total of 200 hrs.**

In **Phase-II** the successful bidder shall be proposed a **400 hrs.** of training module to the regular UG/PG students of the Dibrugarh University in AY 2025-26 that must align with his/her career objectives.

For example, a student Pursuing B.Com. can be proposed a course like “**Business Support Practitioner**”.

Similarly, a student pursuing B.Ed. Program can be proposed a course like “**Career and Education Counselor/Training Centre Manager**”.

A mapping of Employability Enhancement Skill Development Training Program of 400hrs. must be done by the Selected Applicant for the student of All the Departments (the list of departments of Dibrugarh University can be access from the link (<https://www.dibru.ac.in>) & the same has to be submitted to Dibrugarh University for approval.

Phase-III shall include assessment, NSDC certification, placement and awareness programs, regular job fairs, aligning of the local and national employers for providing the employment opportunities for the final year batch of students.

16. Disqualification:

The Dibrugarh University may at its sole discretion and at any time during the evaluation of EoI, disqualify any applicant, if:

- a. The applicant submitted the EoI after the last submission date deadline, made misleading or false representations in the forms, statements and attachments submitted in proof of the eligibility requirements.
- b. Earnest Money Deposit (EMD) amount not paid online and valid EoI aligned Micro, Small, and Medium Enterprises (MSME) certificate for EMD exemption is not submitted along with the bid.
- c. Exhibited are cord of poor performance such as abandoning works, not properly completing the contractual obligations, inordinately delaying completion or financial failures in any project in the preceding three years.
- d. Submitted an EoI that is not accompanied by required documentation as per Section 11 or is non-compliant as per Section 10 in Initial Eligibility and Qualification Criteria.
- e. Failed to provide clarifications related thereto, when sought.
- f. Submitted more than one EoI.
- g. Was declared ineligible/blacklisted by the Government of India/State/UT Government; should not be in litigation with any Government in India.

17. Confidentiality information relating to the examination, clarification, comparison and evaluation of the EoI submitted shall not be disclosed to any of the responding applicants or their representatives or to any other persons not officially concerned with such process until the evaluation process is complete. Undue use by any applicant of confidential information related to the process may result in rejection of its EoI.

18. Disclaimer

- a) The information submitted in response to this EoI may be subject to the public release (as per RTI norms). Therefore, do not include proprietary or confidential business information in your response. Applicants responding to this invitation assume the risk of public disclosure if confidential information is included.
