INTRODUCTION

1. 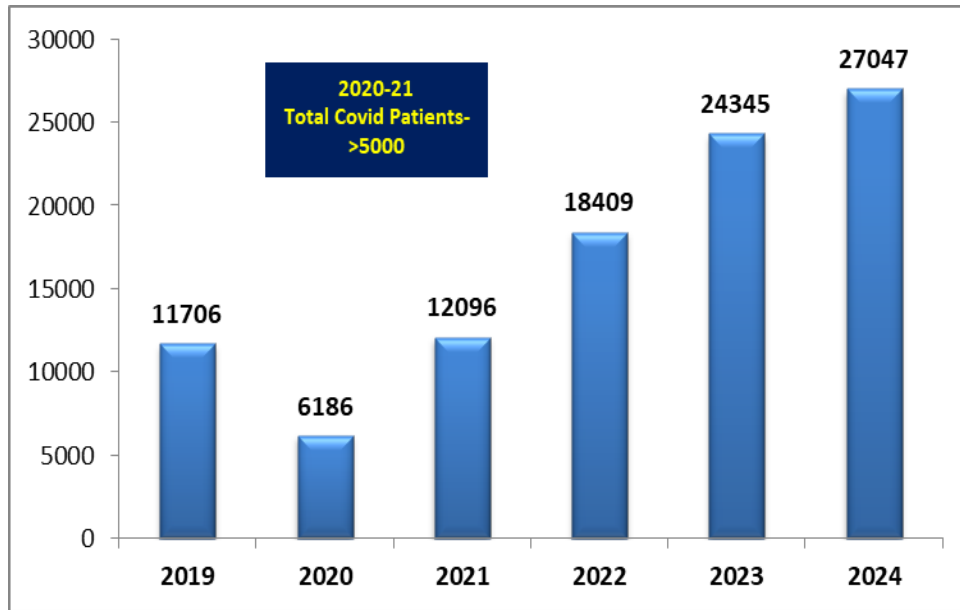

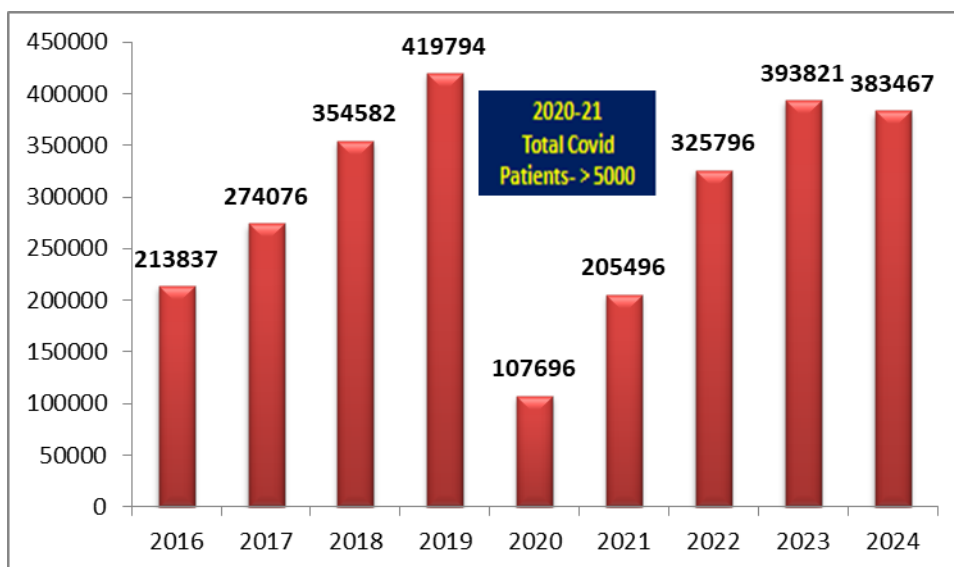

The detail scope of work / services are as follows:-

a. Responsibility of GIMS:

b. The Service Provider will be responsible to provide –

- xiii. Provide courseware and supporting training material for candidates
- xiv. Managing faculty for training. Faculty will be hired as per the policy.

9. FINANCIAL IMPLICATIONS-

- a. The agency will provide specific details for management of IAHS
- b. The fees for the courses will be as per the prevailing rates of various academic institutions and professional associations.
[Rates for GIMS staff will be 50% of outside candidates]
- c. The fees will be deposited on the cash collection counter of GIMS. The service provider will provide the monthly bill to the institute based on number of students enrolled.
- d. Digital transactions will be preferred as far as possible.
- e. The payment to the agency will be provided within 7 working days to the agency after deducting the GIMS processing charges.
- f. The Agency will provide percentage of charges (fees) to be given to GIMS on account of management of IAHS.

10. GIMS RESERVES RIGHT

- (i) To take final decision regarding empanelment or to modify or scrap the process,
- (ii) To accept or reject the request of any agency for empanelment, and
- (iii) To keep or remove any agency on the panel approved for outsourcing trained technician

11. ELIGIBILITY CRITERIA

Agency Should have all the valid registration documents for compliance to all statutory requirements i.e., registration with appropriate authority.

12. GENERAL TERMS AND CONDITIONS

- i. Applications should be submitted in the prescribed form only. Eligible and competent agencies will be short- listed for the empanelment.
- ii. Selection of agency will be done on the basis of criteria enumerated in these documents along with professional competence.
- iii. The selected agency will manage Skill Center –GIMS.
- iv. The selected agency as per the above fee structure can quote their cost/student/course.
- v. Once the project cost is evaluated their quoted share can be raised as bill to GIMS on monthly basis. The institute will make payment within 07 days to the service provider.
- vi. Duration of courses may vary as per the course selected by the student ranging from 1month to 6month.
- vii. Service provider must use their own resources for providing the services allotted to them
- viii. The agency should furnish all the particulars related to its status and functioning.
- ix. The date of declaration of qualified/empanelled agency will be at the discretion of GIMS.
