1. Introduction:

- 1.1. State Project Office Samgra Shiksha, Government of Chhattisgarh (herein after referred to as "SPOSSGoCG") has implemented various projects at the Government Senior Secondary Schools level under the umbrella of 'Samagra Shiksha' to provide quality education to the students.
- 1.2. Ministry of Education, government of India has introduced Vocationalisation of Secondary and Higher Secondary Education under Centrally Sponsored Scheme to integrate employability education into School Education in September 2011. In 2018, this scheme got further revised and brought under the integrated initiative under Samagra Shiksha by MoE and termed as Vocationalisation of School Education (VSE). The revised norms allow a student to complete training in one Job Role in 9th and 10th standards; followed by another Job Role in 11th and 12th standards. The teacher handbook and the student curriculum and courseware are already



developed by PSSCIVE (Pandit Sunderlal Sharma Central Institute of Vocational Education, Bhopal), based on the NOS set by the SSCs.

- 1.3. The scheme is being operated within the NSQF (National Skill Qualification Framework), which establishes a system of clear educational pathways from school to higher education while providing certification of vocational skills. The Government of Chhattisgarh has already been implemented VSE in 592 high and higher secondary Schools under 10 Trades in the previous years.
- 1.4. The Project Approval Board (PAB) of Samagra Shiksha, MoE has approved 552 Government schools in the FY 2023-24 and 100 Government schools under Samagra Shiksha and 41 PM SHRI schools in FY 2024-25. The implementation of this is under progress. The schools have already been identified by the Samagra Shiksha, Chhattisgarh.
- 1.5. The work profile of VTP includes deployment of the vocational trainers, organise awareness/publicities campaigns, counselling, conducting Guest Lectures, hands on skill training/on-the job training, assessment, organizing job fairs, Industry visit etc and any other items as may be added by Samagra Shiksha, Chhattisgarh later.
- 1.6. Accordingly, Samagra Shiksha, Chhattisgarh invites request for proposal from experienced, qualified Organizations having experience in the field of Vocational Education Program in Government Schools for implementation of the VE in 652 Schools approved under Samagra Shiksha and 41 schools approved under PM SHRI schools (Annexure- 11) in Chhattisgarh. The no. of schools may increase or decrease. The Samagra Shiksha, Chhattisgarh is willing to make the entire Training Delivery in **15 trades in 652 Government Schools and 41 PM SHRI Government Schools**, to NSDC-approved Training Partners for the academic session 2024-25. (herein after referred as "The Project")
- 1.7. An MoU will be done between the Samagra Shiksha, Chhattisgarh with successful VTPs with LoI.
- 1.8. The funding of the Project will be done by Samagra Shiksha, Chhattisgarh as per the approved budget by PAB, MoE, Government of India. However, and as per the MoU with Successful VTP(s).
- 1.9. This REOI is intended to shortlist NSDC-approved Training Partners for the trades mentioned in 1.10 in the schools (Annexure- 11) of Chhattisgarh.

2. Scope of work

2.1.1. Vocational Training Provider (VTP):

The Vocational Training Provider (VTP) will be responsible for and expected to: -

- Provide Vocational Trainers as per the requirement of the project.
- A full-time Vocational Trainer is to be deployed in each school, allocated to the Training Partner, as per the Sector/ Job role. The qualifications of the Vocational Trainer should be as per the norms prescribed SPOSSGoCG recommended by PSSCIVE, Bhopal / State, as provided in Annexure- 06.
- To understand the curriculum and course content prepared by PSSCIVE and ensure its delivery through its vocational trainers, within the stipulated time (provided Competency Based Curriculum (CBC) from PSSCIVE, Bhopal) and meet the quality parameters.
- To ensure & conduct the internal formative assessment Continuous Comprehensive Evaluation (CCE) of students as per the norms of the Board of Secondary Education, Chhattisgarh.
- To ensure that theoretical & practical classes are conducted as per Scheme guidelines.
- To ensure mobilization of students, parents, teachers at the community level under the guidance and consultation with the concerned school's Principals.
- To provide guidance and counselling services to the students and their parents/guardians as and when required.
- To arrange relevant industrial visits (minimum of 2 industrial visits in a year) for classes 9th to 12th. On the Job Training (OJT) for classes 9th to 12th for 80 hours for practical exposure and real-life work experience, in an academic year.
- As per law, only those persons who are above the age of 18 years can be employed full-time. Some students in schools with vocational education courses are not eligible for the job as they are underage. The VTP should ensure to provide apprenticeship to at least 70% of the interested students, who are below the age of 18, and thereafter a job. The VTP should ensure jobs to at least 70% of the interested students who are of 18 years and above.

2.1.2. State Project Office Samagra Shiksha, Government of Chhattisgarh (SPOSSGoCG) is the implementing organization and will be responsible for activities such as: -

- Budgeting and expenditure** — Obtain and manage the MOE funding as per the Centrally Sponsored Scheme of Vocationalisation of Secondary and Higher Secondary Education, and the State funds for the project implementation. Allocate budget and sanction expenses because of the sanctioned plan per school for the activities/interventions identified and entrusted to Service Provider/Vocational Training provider. Selection by the State Government is subjected to availability/ approval /release of funds by the Central and State Government.
- Identification of districts/ schools** - The Selection of Districts / Schools/ Trade or Sector.

- c) **Communication and marketing plan:** To create awareness, and stakeholder engagement, and bring in the right talent into the NSQF program. Counselling of students & parents to enrol in the program.
- d) **Identification of Training Provider:** The State Government will identify Vocational Training providers for trades/sectors through the selection process prescribed in the REOI issued by the SPOSSGoCG
- e) **Advisory Group:** To establish advisory/management groups at the various levels for monitoring/feedback/regular assessments process.
- f) **Training of Trainers:** SPOSSGoCG would undertake the "Training of Trainers (TOT)" program in consultation with PSSCIVE, NSDC/SSC, at periodic intervals to update faculty/ instructors/Vocational Trainer with the content developed, training methodology, and adaptation to industry need as per the guidelines of the scheme and financial ceiling.
- g) **Infrastructure for Setting up Lab:** To procure equipment and instruments and set up a lab-cum-classroom in consultation with Vocational Training Provider, Vocational Trainer & related SSCs as per the norms laid down by the GOI will be done by SPOSSGoCG.
- h) **Maintenance of Tools & Equipment's** — To maintain tools and equipment installed in the school as well as ensure availability of raw materials for practical classes.
- i) **Text Books for Students** — SPOSSGoCG will provide free textbooks to students.
- 2.2 **Project Site:** 652 Government Schools and 41 PM SHRI Government Schools & have been selected for the implementation for the project. The list of school is provided in REOI "ANNEXURE-11".
- 2.3 **The third-party engagement:** The Vocational Training Provider shall provide a single point of contact (SPOC) with SPOSSGoCG and shall be solely responsible for the execution and delivery of the work. It shall not further outsource the work to a 3rd party including its franchisees/licensees.
- 2.4 **Number of Sectors/Trade:** One Applicant may apply for all trades being offered through an REOI .

1. Exclusion of REOI / Disqualification

- b. The officer to whom an appeal is filed under (a) above shall deal with the appeal as expeditiously as possible and shall endeavour to dispose it off within 30 days from the date of filing of the appeal.
- c. Procedure for disposal of appeal:
 - i The First Appellate Authority or Second Appellate Authority, as the case may be, upon the filing of the appeal, shall issue notice accompanied by a copy of the appeal, affidavit, and documents, if any, to the respondents and fix the date of hearing.
 - ii On the date fixed for hearing, the First Appellate Authority or Second Appellate Authority, as the case may be, shall, -
 - 1) hear all the parties to appeal, present before him; and
 - 2) Peruse or inspect documents, relevant records, or copies thereof relating to the matter.
 - iii after hearing the parties, perusal or inspection of documents and relevant records or copies thereof relating to the matter, the Appellate Authority concerned shall pass an order in writing and provide a copy of the order to the parties to appeal free of cost.
 - iv No information which would impair the protection of essential security interests of India, or impede the enforcement of the law or fair competition, or prejudice the legitimate commercial interests of the applicant or the SPOSSGoCG shall be disclosed in a proceeding under an appeal.

7. Stay of procurement proceedings

While hearing an appeal, the officer or authority hearing the appeal may, on an application made on this behalf and after giving the parties involved a reasonable opportunity to be heard, stay the procurement proceedings pending disposition of the appeal if he or she is satisfied that failure to do so will result in a perversion of justice.

8. Vexatious Appeals & Complaints

Whoever intentionally files any vexatious, frivolous, or malicious appeal or complaint with the intention of delaying or defeating any procurement or causing loss to any SPOSSGoCG or any other applicant, shall be punished with a fine which may extend to twenty lakh rupees or five percent of the value of procurement, whichever is less.



9. Offenses by Firms/ Companies

- a. Where an offence has been committed by a company, every person who at the time the offence was committed was in charge of and was responsible to the company for the conduct of the business of the company, as well as the company, shall be deemed to be guilty of having committed the offence and shall be liable to be proceeded against and punished accordingly:
Provided that nothing contained in this sub-section shall render any such person liable for any punishment if he proves that the offence was committed without his knowledge or that he had exercised all due diligence to prevent the commission of the such offence.
- b. Notwithstanding anything contained in (a) above, where an offence under Act/Rules has been committed by a company and it is proved that the offence has been committed with the consent or connivance of or is attributable to any neglect on the part of any director, manager, secretary or other officers of the company, such director, manager, secretary or other officers shall also be deemed to be guilty of having committed such offence and shall be liable to be proceeded against and punished accordingly.
- c. For the purpose of this section-
 - i "Company" means a body corporate and includes a limited liability partnership, firm, registered society or co-operative society, trust or other association of individuals; and
 - ii "Director" in a relation to a limited liability partnership or firm, means a partner in the firm.
- d. Abetment of certain offenses: Whoever abets an offence punishable under this Act, whether or not that offence is committed in consequence of that abetment, shall be punished with the punishment provided for the offence.

10. Debarment from submission of REOI / Bidding

- a. An applicant shall be debarred by the State Government if he has been convicted of an offence
 - i under the Prevention of Corruption Act, 1988 (Central Act No. 49 of 1988); or
 - ii under the Indian Penal Code, 1860 (Central Act No. 45 of 1860) or any other law for the time being in force, for causing any loss of life or property or causing a threat to public health as part of the execution of a public procurement contract.
- b. An applicant debarred under (a) above shall not be eligible to participate in a procurement process of any SPOSSGoCG for a period not exceeding three years commencing from the date on which he was debarred.
- c. If SPOSSGoCG finds that an applicant has breached the code of integrity prescribed in terms of the code integrity for applicants" above, it may debar the applicant for a period not exceeding three years.
- d. Where the entire performance security or any substitute thereof, as the case may forfeited by SPOSSGoCG in respect of any procurement process or procurement contract, debarred from participating in any procurement process undertaken by the SPOSSGoCG three years.
- e. The State Government or SPOSSGoCG, as the case may be, shall not debar an applicant such applicant has been given a reasonable opportunity of being heard.

11. Penalty Clause

- a. **Delay in the initial joining of trainers deployed by VTP beyond the agreed upon dates which is prepared by SPOSSGoCG: -**

The penalty of Rs. 500 per calendar day of delay would be charged. In case of delay in special & remote areas, permission needs to be taken from SPD SPOSSGoCG for an extension of the date of joining for up to 10 days.

- b. **Absence of Vocational Trainer from allotted school for more than 5 working days working days with intimation:**

The penalty of Rs. 500 per calendar day of absence shall be imposed on the concerned copy of the leave application should be sent to SPOSSGoCG through Principal with the respective invoice).



c. Vocational Coordinator who is not visiting allotted schools during a calendar month:

A fine of Rs.500/- will be imposed for each missed visit, against the target of a minimum of 22 (in case of fewer than 22 schools) visit per month.

d. The continued absence of vocational trainer from allotted school for more than intimation

A show cause notice will be issued to Vocational Training Provider on the 2nd day of the absence vocational trainer. In case The Vocational Training Provider does not reply within three calendar Providers' reply is not found satisfactory by SPOSSGoCG, then the SPOSSGoCG will consider this as a case case of providing a dissatisfactory service, the SPOSSGoCG can initiate action against VTP only after hearing to the VTP.

- e. **Guest Lecture** — If 2 guest lectures are not conducted in a month (excluding long summer & Diwali, and half-yearly & yearly exams or reason provided by School Principal) then a penalty of Rs. 500 for every missed guest lecture will be imposed on VTP.
- f. **Industrial Visit for class 9th to 12th** - For each industrial visit did not conduct a penalty of Rs. 2000 per visit will be imposed on VTP.
- g. **On the Job Training (OJT) for classes 9th to 12th** — If any VTP does not conduct OJT of a minimum of 80 hrs every year academic session (during vacations) then a penalty amounting to Rs. 100 per student per day OJT not conducted shall be applicable.
- h. In case of breach/violation of any MOE/NSDC norms and other reasons, the SPOSSGoCG levying appropriate penalties in cases other than those mentioned from clauses (a) to (g)

Note: (i). Fraction of a day in the reckoning period of delay in supplies shall be eliminated if it is less than half a day.

(ii) If the Vocational Training Provider requires an extension of time in completion of contractual supply on account of the occurrence of any hindrances, he shall apply in writing to the authority the same immediately on the occurrence of the hindrance but not after the stipulated date of completion of supply.

12. Other Terms

- a) In case any applicant refuses to sign an agreement with SPOSSGoCG after school allotment, in such circumstances SPOSSGoCG will forfeit the bid security submitted by the applicant as per Chhattisgarh Store purchase and services rule 2002 (updated 2024).
- b) Performance Bank Guarantee (Security Deposit) – Whereas the approved VTP has to deposited with the Managing Director, Samagra Shiksha, Chhattisgarh, Raipur a sum of Rs equal to 3 months of salary of all VT allotted to VTP OR as per applicable according to Chhattisgarh Store purchase and services rule 2002 (updated 2024) of total estimated payment made to VTP including reimbursement) as security deposit for the due and faithful performance of the agreement, it shall be forfeited in the event of supplier not performing his duties as per terms of the agreement. DD/bankers cheque/Bank Guarantee in the name of Managing Director, Samagra Shiksha Chhattisgarh, Raipur (Annexure – 09) to be submitted. If desired, the selected applicant can adjust the amount of bid security in the performance security deposit amount.
- c) A trainer would normally be able to avail of school vacations (except summer vacations) as per the school calendar. In case the principal needs help on some day during the school vacations, the trainer would need to full fill the same.
- d) Vocational Trainer notwithstanding the penalty terms in case VTP does not put into place for more than 30/31 calendar days from the originally stipulated date then the school may be allotted to another VTP.
- e) Any VTP who like to discontinue CSS for VSHSE program during the period of the signed agreement with SPOSSGoCG then the VTP shall inform about it in writing three months in advance before ending the agreement. However, such will not be eligible to participate in the REOI for the next three forthcoming years. The SPOSSGoCG will allot the concerned schools to other VTPs. In such circumstances, the PBG submitted by VTP will be forfeited.
- f) If any applicant breaches the agreement during the tenure period, SPOSSGoCG reserves the right to take any of the following actions: (a) Forfeiting of the Performance Security, (b) Distribution of allotted school




- to other VTPs, (c) Taking appropriate legal action/lodging of FIR against the firm (d) Debarment of the VTPs.
- g) Always ensure compliance with the circular of Chhattisgarh Store purchase and services rule 2002 (updated 2024) and GFR GoI 2017 and all other applicable rules.
 - h) The SPOSSGoCG reserves the right to increase/decrease the number of vocational education schools to be allotted.
 - i) The VTP shall always ensure compliance with all guidelines and circulars etc. being issued from time to time by the State Government/ Managing Director for implementation of the scheme.
 - j) The vocational education agreement for CSS-VSHSE will initially be for minimum 3 academic years. MOU can be further extended to one more year after the mutual consent of both parties.
 - k) All other terms and conditions of the REOI will adhere to Chhattisgarh Store purchase and services rule 2002 (updated 2024) and GFR GoI 2017 and all other applicable rules.
 - l) The bidder should quote Single management Charge for all the school of all Trades AS the work to be performed by VTP is the same in different trades. The bidder should not leave blank in the financial bid document.
 - m) For uploading an online bid document, the digital signature of the bidder is mandatory. All bidders should procure digital signatures timely.  - r) The VTPs must do the job placement tracking for 06 months for the 12th pass-out students of previous years who have obtained the job in all schools. The relevant data of these students will be made available to the VTPs by the school authorities. A quarterly report related to it will be submitted by VTP to SPOSSGoCG Raipur.
 - s) The remuneration shall be paid to the Vocational trainer on monthly basis regularly by the VTPs. The VTPs shall release VT honorarium without any fail, even in case payment is under process from the SPOSSGoCG side. In the case of non-compliance to terms of EOI, SPOSSGoCG reserves the right to transfer the allotted schools of such VTP to another training provider, or any other appropriate action may be taken against such training provider (as mentioned in Other Terms Point no. g).
 - t) In order to be appointed as a Vocational Trainer in state government English Medium schools (existing or future) the trainer should have fluency in the English Language along with excellent written and oral communication skills.
 - u) If selected VTPs are offered schools under the HUB & Spoke model then according to SPOSSGoCG guidelines, they must carry out the teaching and training activities in the assigned schools through their vocational trainers.
 - v) VTs will be involved in the following activities during the summer and winter vacations: promotion's the vocational education Scheme, public. Awareness, and parent and student counselling. (b) Action plan preparation through identification and coordination of nearby industrial units/institutions for activities such as OJT/Industrial Visit, job placement, Internship, and so on, as well as keeping a record of willing students Planning and preparation for upper primary level students exposure activity by liaising with local artisans, craftsmen, etc.
 - w) The minimum bid for the management charges for total remuneration paid to vocational trainer by VTP will be minimum 5 % and maximum 15 % of the amount of prescribed remuneration for them.
 - x) The final terms and conditions of the agreement will be according to the memorandum of understanding as finalise by the Samagra Shiksha Chhattisgarh at the time of Signing of Agreement.









- y) This REOI is only for short listing the Successful bidders according to selection criteria prescribed in Bid document.
- z) Managing Director Samagra Shiksha Chhattisgarh holds all the powers and authority to allot the schools in specific trades to the Short listed / Successful bidder according to the criteria decided by the state level committee.
- aa) All the documents submitted/uploaded must have page number and must be stamped and signed on every page by authorized person of the VTP. If improper page numbering or unsigned documents are found, then the proposal shall be rejected.
- bb) All the documents submitted must be scanned copy of original documents. Scanned copies of xerox or photocopies of the original documents will not be accepted and shall be treated as disqualified.
- cc) The scanned copies must be clearly visible and should be readable to understand to fulfil the eligible criteria. Illegible/ambiguous submitted documents will not be accepted and will not be evaluated and shall be treated as disqualified.
- dd) The Samagra Shiksha, Chhattisgarh will not be responsible for internet connection failure / electricity failure / computer system crash / network problems / browser issues etc. during uploading of the documents on e-portal. - hh) In Case of any dispute all the legal and judicial lies within the jurisdiction of Raipur, Chhattisgarh.
- ii) The Managing Director Samagra Shiksha Chhattisgarh holds the powers to terminate the entire bid process at any time of its validity period.

If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected unless in the opinion of the Procuring Entity there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected;
- ii. If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail, and the total shall be corrected, and.
- iii. If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to clauses (i) and (ii) above.

If the Bidder that submitted the lowest evaluated bid does not accept the correction of errors, its Bid shall be disqualified, and its Bid Security shall be forfeited or its Bid Securing Declaration shall be Executed.

2. Procuring entity's right to vary quantity/units:

- i. The units originally indicated in the bidding document may vary without any change in the unit prices and other terms and conditions of the bid and the conditions of the contract.
