TERMS OF REFERENCE (ToR) FOR "Providing Recognition of Prior Learning (RPL) training to youth of Punjab."

1. Purpose and Scope of work

Punjab Skill Development Mission (PSDM) proposes to engage agency(ies) out of its empaneled training partners in the State of Punjab for carrying out **Recognition of Prior Learning (RPL)** as mentioned in scope of work at **Annexure-A**.

2. Documents to be submitted and the Eligibility criteria for selection of agencies

The documents to be submitted with the application and the eligibility criteria for selection of agencies is as per Annexure-B, B1, B2, C and Annexure D.

3. Application Submission Guidelines

The application shall be submitted on e-procurement portal www.eproc.punjab.gov.in only in accordance with the following guidelines:

- a) Application shall be submitted in the format as per Annexure-C.
- b) The application shall be unconditional; otherwise it shall be rejected.
- c) All the information/details are to be supported by authentic documents duly certified by the Applicant with signatures on each page.
- d) Applications shall be submitted on e-procurement portal www.eproc.punjab.gov.in only. Any other means of submission will not be accepted and will be summarily rejected.
- e) Tender Fee shall be Rs 1000/-.
- f) Processing Fees shall be Rs 10,000/-.
- g) EMD shall be Rs. 15,000/-.
- h) Performance Bank Guarantee @ 10% of total project cost with validity till 15-05-2025 shall be submitted by the shortlisted agency within 05 days of issuance of work order.
- i) The EMD of successful bidder shall be refunded after submission of Performance Bank Guarantee (PBG).
- j) The Performance Bank Guarantee (PBG) shall be released in 01 month after completion of work order and payment of all installments as per schedule. Non submission/wrong submission of claim as per guidelines and timelines of any/all installment will result in forfeiture of Performance Bank Guarantee (PBG).
- k) One applicant is allowed only one application. The applicant may apply for multiple job roles at different centres in this application.

Scope of Work

Role of Training Partner

- 1. The training will happen at the Industry clusters, premises, camps and training centres of training partners. The training partner will be responsible for ensuring the readiness of the Training premises, including setting up the classroom for conducting the training, providing ToT-certified trainers, as well as managing the training, monitoring and assessment of candidates by the Sector Skill Council as per Annexure A. District wise list of Job Roles is attached at Annexure- E.
- 2. Entire training for which the work order that will be given to the successful agency (ies) by PSDM under this shall have to be completed as below.
 - a. The training including assessment and certification must be completed by March 27, 2025.
 The final installment bills must be submitted by March 29, 2025, after which no claims will be entertained, and the Performance Bank Guarantee (PBG) will be forfeited.
- 3. Failure to claim any/all instalments as per the guidelines may lead to de-empanelment of the agency.
- 4. Centre accreditation shall be under Non A&A. Further, infrastructure w.r.t area required for lab, Projectors in classroom, internet at the training centre, pantry, AC, biometric attendance shall be as per the guidelines of PMKVY scheme.
- 5. Eligibility criteria of candidates to be trained will be as per Punjab Hunar Vikas Yojana (PHVY):- "The RPL component of the scheme aims to provide the assessment & certification of individuals having prior learning experience or skills but are not having relevant certification. Candidates with Aadhaar card and aged above 14 years as on commencement of training shall be eligible to get benefit under this training."
- 6. Assessment fees is to be paid by the training agency which shall be reimbursed to the training agency by PSDM. Re-assessment fees shall not be paid / re-imbursed by PSDM.
- 7. Costing and payments shall be as per common cost norms of latest PMKVY 4.0 guidelines for the applicable components. Depending upon duration of training (30/60/132 hrs) and the premises where training is being implemented.
- 8. No subletting of work is allowed and in such case the agency will be de-empaneled by PSDM.
- 9. Detailed terms and conditions shall be issued in the work order.
- 10. The short listed bidder shall have to appoint a fact knowing SPOC for easy coordination.
- 11. The short listed agency will have to commence the training within 03 days of the issuance of the work order. The penalty for non-commencement of training will be applicable as below:-

- 12. Any adjustment/recovery raised by PSDM and not deposited/ no suitably reply given by the applicant will result in forfeiture in Performance Bank Guarantee (PBG).
- 13. Non responsiveness/poor performance or furnishing of incorrect information may also lead to forfeiture of Performance Bank Guarantee (PBG).
- 14. In case of non-submission of the Performance Bank Guarantee (PBG) within 5 days of the issuance of the work order, a penalty of INR 1,000 will be imposed for the next 5 days. On the 6th day, the Performance Bank Guarantee (PBG) will be forfeited, and no further communication will be made.

- 3. Applicants/ Agencies scoring less than 16 marks in eligibility and presentation or not present in the presentation round will be considered ineligible for further evaluation.
- 4. Any agency that is selected and issued a work order may be allocated additional targets in the same job role at other locations also, if no other agency is found eligible.
