A. INSTRUCTIONS FOR SUBMISSION OF TENDER FORM & DOCUMENTS

- 01 EOI फार्म मय शर्तों सहित ऑन—लाईन वेबसाईट http://eproc.rajasthan.gov.in or http://sppp.rajasthan.gov.in पर निविदा सूचना में दर्शाये अनुसार डाऊनलोड तथा निविदा प्रपत्र को भरकर मय डिमाण्ड ड्राफ्ट वेबसाईट पर निर्धारित प्रपत्र में अपलोड किया जा सकता है।
- 02 EOI की समस्त प्रक्रियायें ऑनलाईन होगी।
- 03 EOI में रुचि लेने वाले निविदादाता प्रपत्र को वेबसाईट http://eproc. rajasthan.gov.in से डाउनलोड कर सकते है। निविदादाता द्वारा निविदा शुल्क डिमाण्ड ड्राफ्ट के रूप में सम्बन्धित कार्यालय में निर्धारित तिथि तक जमा कराना आवश्यक होगा।
- 04 EOI में भाग लेने वाले निविदादाताओं को वेबसाईट http://eproc.rajasthan.gov.in पर रजिस्टर करवाना होगा। ऑनलाईन EOI में भाग लेने के लिए डिजिटल सर्टिफिकेशन इन्फोरमेशन टेक्नोलोजी एक्ट 2000 के तहत प्राप्त करना होगा जोकि इलेक्ट्रोनिक निविदा में साईन करने हेतु काम आएगा। निविदादाता उपरोक्त डिजिटल सर्टिफिकेट सी.सी.ए. - 05 Training Firms should submit their proposal in the format in BoQ (Financial Bid), however DD of EOI form, EOI-processing charges and EMD should be submitted at Urmul Dairy Plant Office, Bikaner on or before the due date and time.
- 06 Rates for each training type should be quoted separately.
- 07 The rate quoted in the EOI will be valid for one year.
- 08 Before submitting the EOI, it should be ensured that all the EOI papers including the terms and conditions of the EOI are signed by the bidder.
- 09 Successful party has to deposit 10 % Security Deposit that can be deposited after adjusting EMD. This may also be deducted from the bills of training.
- 10 Earnest Money Deposit (EMD) and Security Deposit (SD) are refundable after 3 months from the date of billing.
- 11 The tender shall be considered and accepted only on the basis of terms and conditions of the Urmul Dairy, no separate condition of the tenderer/firm shall be accepted.
- 12 Any condition in the T&C of the contract may be added or reduced if a special circumstance arises in the interest of the Milk Union.
- 13 Please read carefully the steps of submitting Tender.



B. <u>SCOPE OF WORK & RELEVANT TERMS & CONDITIONS FOR SUBMISSION</u> OF EOI:

- 1. The Unit Rate must be quoted against each training type in the prescribed format (BoQ).
- 2. The rate quoted shall be valid for full one year and extendable for another one year if the performance is found satisfactory.
- 3. Training, in case, is extended for another one year, the rate shall remain unchanged. Other terms and conditons would also remain same & applicable.
- 4. Request for Expression of Interest (REOI) is invited for providing trainings under NPDD program. The topics are as follows:
 - a. Training of Famers in good hygienic practices/good mfg. practices
 - b. Training of Dairy Personnel/ Milk Tester (Including Plant & Marketing Staff) (3 days)
 - c. Training of Quality Management systems (3 days)
 - d. Training of DCS Staff/ BMC/ CHILLING CENTRE/AMCU/ DPMCU on Operation & Quality Management.
- 5. Rate quaoted should be inclusive of GST.
- 6. Rate should include include all expenses viz refreshment, training Hall, projector, audio visual equipment, stationary etc.
- 7. Trainees that shall undergo training of duration of 3 Days (Training of b & c type), shall be provided additionally stay, breakfast and meals arrangement also.
- 8. Bikaner Milk Union will provide assistance in planning and coordinating management activities between milk producers/banks, trainees, trainer firms & Support will be provided to the milk union through timely communication and availability of information about the number of trainees, their contact details, academic and social details.
- 9. The training firm should have knowledge and experience of imparting training for co-operative dairy sectors so that the trainees have a sense of engagement and get relevant cases and examples of co-operative dairy operations and management.
- 10. The EOI firm should have conducted more than 5 nos training programs related to Good Manufacturing, Good Hygiene Practice, Clean Milk Production, Milk Testing, BMC Operation & Management, HACCP, Food Safety Mgmt System- ISO 22000- Internal Auditors Development & Qualification Trainig, Quality & Food Safety- Training & Awareness aligning BIS/ ISO 9001/ FSSAI- FOSTAC/ ISO 22000 standard in Milk Supply Chain, Cattle Care Management, Feed & Fodders, Breeding Improvement, Awareses on aspects & benefits of Cooperative Dairy Sectors etc.
- 11. The Firm should be preferably located in the state of Rajasthan.
- 12. The firm has to submit the consent in the prescribed format (Annexure-2)
- 13. The firm should have qualified trainers from BIS/FOStac/NPDD or the trainers should have experience in organizing or conducting NPDD trainings. They can be retired personnel from quality, processing or P&I or even lead auditors and trainers on ISO 22000/Food Safety.
- 14. The firm which has any case pending against the Milk Union or its officers/employees (related to functioning of the Dairy) will not be accepted.
- 15. Firms which are presently or in the past under contract with Milk Federation or any other Milk Federation and have been caught/penalized in any case shall not be eligible to participate in this EOI. The Affidavit in the prescribed format (Annexure-2) should be attached.
- 16. Any firm which has been blacklisted/contract terminated/suspended by RCDF or its affiliated Milk Union in the past will not be considered for this EOI.

- 17. The employees/ Board members & their family member of Urmul Dairy or its Parent organization RCDF are not eligible for participation in EOIs.
- 18. The firm must have GST Registration Certificate. (Attach the Copy)
- 19. Bidder must submit list of clients. Bidder must have conducted more than 10 trainings. (At least 5 trainings should be from cooperative dairies)
- 20. It shall be mandatory for the contractor to provide a photocopy of his or her organization's permanent account number (PAN).
- 21. The bidder must ensure that the individual PAN card is linked to Aadhaar. In case of non-linking, if any penalty or liability arises from the Income Tax Department, it shall be the sole responsibility of the tenderer/contractor.
- 22. Turnover of the bidder should not be less than 30 Lakhs in each of the last 03 years. ITR of last three years should be enclosed. (Attach the Copy)
- 23. Bidder should have ISO 9001: 2015 Certification. (Attach the Copy)
- 24. TDS, as applicable, will be deducted from the bill.
- 25. In case of any dispute, the decision of the Managing Director of Urmul Dairy would be final.
- 26. Bikaner shall have the judicial jurisdiction to settle any dispute.
- 27. The bidder shall comply with all statutory and mandatory provisions of labour/industrial laws in force from time to time.
- 28. The selected training firm is required to submit bills for each training programme either fully or partially along with documents evidencing training conducted which shall include the following:
 - a. List of Trainees (Approved by BIKANER Milk Union or its representative)
 - b. Training Program Schedule
 - c. Attendance Records
 - d. Training Records
 - e. Training Feed Back
 - f. Phography/ Videography Evidences
- 29. Training sessions and records will be subject to monitoring and inspection by the authorities.
- 30. The firm will not disclose any confidential information relating to the Milk Union which is being shared with you for organizing the work.
- 31. In case of violation of any of the terms and conditions of EOI, Urmul Dairy Bikaner will terminate the work order/contract.
- 32. Payment will be disbursed within 15 days of satisfactory verification by Urmul Dairy Bikaner
- 33. Preference will be given to the firm having experience, technical strength, and good performance in similar field and preferably located in the State of Rajasthan.
- 34. Bikaner Milk Union has full right to cancel the EOI without giving any reasons.
