## Invitation for Expression of Interest (EOI) For Empanelment of NGOs to Implement CSR Initiatives in the state of Odisha

## 1. Introduction

Experience	Minimum of 5 years in community welfare projects, especially in health, education, or skill development.
Financial Capacity	Average annual turnover of ₹20 lakhs over the last three financial years, supported by audited financial statements
Presence in Odisha	Operational presence with a head or branch office in Odisha.
Compliance	Should not have been blacklisted by any government or funding agency.

The bidders are requested to provide documentary evidence in support of the above eligibility criteria as stipulated in Annexure-1.

## **Evaluation and Selection Method for Empanelment**

The evaluation and selection process will comprise two stages: Document-Based Evaluation and Presentation/Interview Evaluation. The overall score will determine the final selection.

## 1. Document-Based Evaluation (70 Marks)

The submitted EOI documents will be evaluated based on the following criteria:

Minimum Qualifying Score: 70 (Full Mark) Shortlisted NGOs will move to the next stage.

# 2. Presentation/Interview Evaluation (30 Marks)

Shortlisted NGOs will present their proposed methodology and implementation plan to an evaluation committee. (Presentation Date shall be intimated to them accordingly) Marks will be allocated based on the following parameters:

## 3. Final Selection and Scoring

The combined score from the document-based evaluation (70 marks) and the presentation/interview (30 marks) will determine the final score for each NGO.

NGOs will be ranked based on their final scores. The highest 3 ranking NGOs will be empaneled. The GRIDCO Ltd. may also consider more numbers of NGOs if required.

## 4. Empanelment Decision:

- Empaneled NGOs will sign a Memorandum of Understanding (MoU) with GRIDCO to formalize their participation.
- Empanelment does not guarantee work allocation. Financial proposals will be invited from the empaneled NGOs for specific projects as per the requirement. Work to be awarded to the L-1 bidder or may be distributed among the other empanelled NGOs at the L-1 rate if mutually agreed at the discretion of GRIDCO.
