**1. INSTRUCTIONS TO APPLICANTS / INTENDING PARTIES**

- a. Applicants are required to read carefully the contents of this document and is expected to examine all instructions, forms, terms and conditions in the EOI documents. Failure to furnish all the information required as per the EOI document or submission of EOI not substantially responsive to the EOI documents in every respect will be at the applicant's risk and may result in rejection of the EOI.
- b. It shall be deemed that by offering EOI, the Bidder has:
  - i. made a complete and careful examination of the documents;
  - ii. received all relevant information and satisfied itself about all matters, things and information hereinabove necessary and required for bidding;
  - iii. acknowledged and agreed that ignorance of any of the matters hereinabove shall not be a basis for any claim for compensation, damages, claim for performance of its obligations, loss of profits, etc. from CSRAA
- c. Applications should be submitted strictly as per EOI form provided in the document. The intending agency shall have to submit copies of all the documents listed in this EOI along with the proposal proforma and cover letter. A certified copy shall have to be submitted wherever applicable.
- d. Eligible selected party/parties shall have to sign an Agreement with CSRAA after completion of selection process.
- e. Any corrigendum including extension of date or change of date for submission of the EOI shall be published only on the website and that shall be deemed to have been seen by the applicants.
- f. ***All the papers of EOI documents with terms and conditions should be duly signed by the Applicants on each page as a token of acceptance of all the terms and conditions.***
- g. CSRAA reserves the right to amend the EOI, cancel this EOI as well as relax or waive any of the conditions stipulated in this document as deemed necessary in the best interest of the CSRAA without assigning any reasons and may include any other item in the Scope of work at any time after consultation with applicants or otherwise
- h. Besides, it reserves the right to change the tentative schedule and critical dates. It is the sole responsibility of prospective applicants to keep themselves updated about any information pertaining to the EOI.
- i. CSRAA shall not be held responsible for any delays. The agency is responsible for verifying the information related to the proposal.
- j. If the closing and opening date(s) mentioned above falls on a non-working day, the closing and opening date(s) will be the next working day.

## 2. Background

With the vision to catalyze sustainable growth by creating an enabling environment for the corporate sector to work in collaboration with the Government, Non-Government and civil society organizations in the field of Corporate Social Responsibility, the Govt. of Assam vide notification dated 16.12.2023 had notified the constitution of the Corporate Social Responsibility Authority of Assam, (CSRAA) along with Rules and Regulations 2023 under the administrative control of Industries, Commerce & Public Enterprise Department. CSRAA has been registered as a Society on 05.04.2024.

Corporate Social Responsibility Authority of Assam (CSRAA) envisages working with Implementing Agencies to execute CSR-led projects across Assam. To this effect, CSRAA would like to empanel agencies/organizations/NGOs/trusts, societies etc. as Implementing Agencies with relevant experience in social development and environmental projects as per Eligibility and Evaluation criteria. Programming quality and implementation will be monitored and evaluated by CSRAA as per its Quality Standards and Procedures.

The objective of involving the agency is to implement CSR-led activities with a focus on the thematic areas identified under the Assam CSR Policy 2019.

## 3. Scope of Work

- a. The State consists of 35 districts. The intending agencies can apply for state-level activities in one or more than one district, as per their preference, which should be clearly mentioned in the cover letter. However, CSRAA shall empanel selected agencies based on their exposure, experience, and performance for any district.
- b. The selected NGOs, Trusts, Social Non-Profit organizations, etc. will have to work as per the Detailed Project Report (DPR)/Scope of Work defined by the sponsoring agency i.e. State Govt, CPSUs or Corporate Houses.
- c. The selected parties are required to provide professional, objective and impartial advice to CSRAA and at all times hold the sponsoring CPSU/Company's interest paramount, without any consideration for future work and avoid conflicts with other assignments or their own interests.
- d. The selected parties must observe the highest standards of ethics during the execution of any projects allocated to them.
- e. The individual projects maybe selected by the CPSUs/Corporate Houses or suggested to them by State Govts. If it is found that an empaneled agency has indulged in any corrupt or fraudulent activity in securing any work order or contract, then the said agency maybe declared ineligible, either indefinitely or for a stated period of time.
- f. The Applicant has to follow CSRAA guidelines and any circular issued by CSRAA for conduct of project allotted to the empaneled members.

#### 4. Clarification of EoI Document

An intending agency requiring clarification of the EoI documents may submit their queries to the CEO, CSRAA, by hard copy or email at [csr.authorityofassam@gmail.com](mailto:csr.authorityofassam@gmail.com) one week before the last date of submission. All queries shall be clarified before the closing timeline of the EoI.

#### 5. Eligibility Criteria for Submission of Proposal

Intending agencies having expertise in implementing (formulating, executing, monitoring and evaluating) social development and environmental projects satisfying the following conditions may submit their EoI:

- a. The Intending Agency should be a compulsory registered entity registered in India as per regulations of the Govt. of India. (Appropriate registration under Society/Trust/Companies Act)
- b. Has experience in implementing social development and environment projects aligned with the thematic areas of Assam CSR Policy.
- c. Possess a Unique ID for NGOs/VOs through the NGO-Darpan portal of NITI Aayog.
- d. Has Audited Financial Statements for the last 3 FYs (Copy of Audited Financial Statements for the last 3 FYs) if the Intending Agency is more than three years old.
- e. Has Audited Financial Statements for the last FYs (Copy of Audited Financial Statements for the last FYs) if the Intending Agency less than three years old.
- f. Has successfully implemented social development and environmental projects in Assam.
- g. Has a bank account in the name of the agency. Accounts should be audited regularly by a Chartered Accountant.
- h. The intending agency must possess and submit the following details:

- i. The agency should not be blacklisted by any Government Department (Self-Declaration that the organization/institute is not involved in any corrupt practices and has not been blacklisted by Central/ State Agencies on non-judicial stamp paper of Rs 10 and duly attested by the notary Public).

## 6. Criteria for Disqualification

Even if an applicant satisfies the above-noted requirement, it is liable to be disqualified if it is found to have:

- a. Made a false representation in the form, statement and attachments required in the documents for this empanelment.
- b. A record of poor performance, such as abandoning assignments, not properly completing contracts, financial failures or delayed completion.
- c. Been convicted by any court of law.
- d. Must not have been blacklisted by any Central/ State Agencies department in the last three years.

## 7. Submission, Receipt, and Opening of Proposal

- a. Intending agencies should read the EoI carefully before preparing and submitting the proposals. **Agencies who do not have the requisite experience and expertise need not apply.**
- b. An authorized representative of the agency shall put the signature on all pages of the original proposal and attached documents.

The copies of the proposal as given under Annexure I shall be submitted mentioning the Proposal for Empanelment as Implementing Agency for implementing CSR Projects in Assam as per the requirement along with cover letter. The documents must be sent to the address or email indicated in the data sheet and received at the CSRAA office or through email no later than the time and the date indicated in the schedule or any extension to this date. Any proposal received by CSRAA after the submission deadline shall be returned unopened.

## 8. Preparation and submission of proposals

The intending NGOs/ Charitable Trusts/ Society are required to study carefully all the proposal documents and prepare his/her/their proposal to comply with all the provisions thereof. Submission of a proposal shall be taken as evidence, and the agency shall be confirmed as having acknowledged all the provisions of the proposal documents and fully acquainted itself with all factors that may influence the preparation of his/her/ their proposal. Negligence of the agency intending to observe instructions in preparing his/her/ their proposal shall be at his/her/ their own risk. It shall not be grounds for securing relief from any error found or discrepancies contained in his/her/ their proposal or a cause for withdrawal of his/her/ their proposal after it has been opened.

The proposal should be completed in all respects and shall consist of the documents/ information as stated in clauses of the Instruction to Intending Agency.



***Conditional proposals and hard copies of proposals not properly sealed shall be rejected.***

## **9. Evaluation of the Proposals**

The criteria for eligibility and qualification of bidders are set out in Clause 5 and 14 of this EOI.

As part of the evaluation, the bids shall be checked for responsiveness to the requirements of the EoI document, and only those bids that are found to be responsive will be further evaluated in accordance with the criteria set out in this EoI document.

The Bid would be considered to be responsive if it meets the following conditions:

- a. It contains all the information and documents as requested in the EoI document.
- b. It contains information in formats specified in this EOI document
- c. It provided information in reasonable detail ("Reasonable Detail" means that, but for minor deviations, the information can be reviewed and evaluated by CSRAA without communication to the bidder). CEO, CSRAA reserves the right to determine whether the information has been provided in reasonable detail.
- d. There are no inconsistencies between the Proposal and the supporting documents.

## **10. Award of Letter of Acceptance.**

Eligible agencies shall be empaneled under CSRAA.

## **11. Duration of the empanelment:**

The agency will be empaneled for 2 years and can be renewed subject to satisfactory performance.

## **12. Payment Schedule**

The relevant terms of payment, time schedule and relevant terms for each work shall be defined separately at the time of assigning the project. Payment will be made as per the approved cost norms for each project.

## **13. Special Provisions of the Contract**

- a. **Safety measures:** The agency to whom the assignment shall be awarded shall be responsible for the safety of all professionals/ staff engaged in implementing the work at their own expense.
- b. **Agreement:** The agency to whom the assignment shall be awarded shall enter into and execute an agreement. The proposal document, letter of acceptance, and document submitted by the successful intending agency shall form part of the agreement.
- c. **Jurisdiction:** For any dispute or all matters arising out of this EoI, the competent court in Guwahati, including the Guwahati High Court, shall have jurisdiction.

- d. **Non-Compliance with the agreement:** If the agency to whom the project is awarded fails to comply with any condition of the agreement, the CEO, CSRAA, shall be at liberty to cancel the project at any stage of progress of the project. In such eventuality, the performance guarantee shall be forfeited.
- e. **Time of completion of the project:** The project is timebound. The project shall have to be completed within the stipulated time of completion as mentioned in the project agreement.
- f. **Force-de-majeure clause:** The project is subject to Force-de-majeure clause as applicable under the law.
- g. **Conflict of interest:** The intending parties are required to provide professional, objective and impartial advice and at all times and hold the sponsoring CPSU/Company's interest paramount, without any consideration for future work and avoid conflicts with other assignments or their own interests.
