Part I

EXPRESSION OF INTEREST FOR EMPANELMENT OF INSTITUTIONS FOR CONDUCTING SURVEY OF TARGET GROUP FOR SKILL DEVELOPMENT TRAINING AND CAPITAL SUBSIDY

NSKFDC invites Expression of Interest (EoI) from Institution/Body/ Trust/Society/NGO/Partnership Firm/LLP/company which meet the eligibility criteria for empanelment to conduct survey of Manual Scavengers/dependents (herein referred to as "Target Group") for ascertaining their willingness for Skill Development Training and/or Capital Subsidy under the National Action for Mechanised Sanitation Ecosystem (NAMASTE), earlier known as Self Employment Scheme for Rehabilitation of Manual Scavengers (SRMS).

OBJECTIVE

The objective of conducting the survey is to identify and ascertain the willingness of Manual Scavengers/ dependants to undergo Skill Development Training and/or avail capital subsidy who have not yet availed these benefits. The survey is to be conducted in 17 States across India.

The organizations fulfilling the conditions shall submit the proposals with requisite documents by 30.05.2025 addressing the same to "The CS & DGM, National Safai Karamcharis Finance & Development Corporation (NSKFDC), NTSC, 3rd Floor, E-Block, NSIC, Okhla Industrial Area Estate-III, New Delhi – 110020. The eligible organizations will be empanelled by NSKFDC.

Note: 1. NSKFDC reserves the right to accept/reject the proposal without assigning any reason whatsoever.

2. NSKFDC reserves the right to extend the last date of submission of proposals on need basis.

Part II

Instructions to Applicants

1) National Safai Karamcharis Finance & Development Corporation (NSKFDC),

a wholly owned Govt. of India Undertaking under the Ministry of Social Justice & Empowerment (MoSJE) was set up on 24th January 1997 as a Company "Not for Profit" under Section 25 of the Companies Act, 1956. NSKFDC is in operation since October, 1997, as an Apex Corporation for all round socio-economic upliftment of the Safai Karamcharis (including Waste pickers), Manual Scavengers and their dependants throughout India, through various loan and non-loan-based schemes.

Apart from operating various loan and non-loan-based schemes for the upliftment of the target group, NSKFDC is playing a vital role in prevention of hazardous cleaning of sewer and septic tanks.

2) Self-Employment Scheme for Rehabilitation of Manual Scavengers (SRMS)

Self-Employment Scheme for Rehabilitation of Manual Scavengers (SRMS) was being implemented for the rehabilitation of persons engaged in manual scavenging. The manual scavengers identified through survey are being provided rehabilitation under the Scheme since 2013. Following the "Prohibition of Employment as Manual Scavengers and their Rehabilitation Act, 2013" (MS Act, 2013), there have been numerous efforts to understand challenges of safe cleaning of sewers and septic tanks and develop approaches, policies, standards, and regulations in order to improve the working conditions in the sanitation sector. Since then, benefits like subsidized loans to sanitation workers for procurement of sanitation-related projects, training support for skill building, workshops on hazardous cleaning of sewers and septic tanks etc. are being provided under SRMS. The identified manual scavengers and their dependents have been provided the following assistance to promote sustainable livelihood:-

- i. One Time Cash Assistance of Rs. 40.000/-.
- ii. Skill Development Training Programmes with stipend @ Rs. 3,000/- per month.
- iii. Capital Subsidy upto Rs. 5.00 lakh for Self Employment Projects

3) **DEFINITION**

Manual Scavenger and Manual Scavenging: As per Manual Scavengers Act,2013 "manual scavenger" means a person engaged or employed, at the commencement of this Act or at any time thereafter, by an individual or a local authority or an agency or a contractor, for manually cleaning, carrying, disposing of, or otherwise handling in any manner, human excreta in an insanitary latrine or in an open drain or pit into which the human excreta from the insanitary latrinesis disposed of, or on railway track or in such other spaces or premises, as the Central Government or a State Government may notify, before the excreta fully decomposes and the expression "manual scavenging" shall be construed accordingly.

Dependent: The dependent of identified manual scavengers is one who is a member of his/her family or is dependent on them. Each identified manual scavenger and his/her spouse or children who are at the age of 18 years and above, who are not employed will be provided admissible benefits.

Family and Dependent are defined for all rehabilitation measures, as under:

- i. Skill Development Training Programme (SDTP)
- ii. Loan with Capital Subsidy

All identified manual scavengers and their dependents who are willing and are above 18 years of age are eligible for skill training and loan with capital subsidy.

4) NAMASTE

The nomenclature of the Scheme has been changed as "National Action for Mechanised Sanitation Ecosystem" (NAMASTE) from the earlier name of "Self Employment Scheme for Rehabilitation of Manual Scavengers" (SRMS). The following existing components of SRMS would continue to be implemented for the rehabilitation of identified manual scavengers and their dependents:-

A) Subject to the eligibility criteria of the training Programmes, identified manual scavengers and their dependents who are willing and are above 18 years of age shall be provided, free of cost, skill training of their choice from the list of such trainings organized by the National Safai Karamcharis Finance and Development Corporation (NSKFDC) from time to time. A monthly stipend of Rs.3000/- (Rupees three thousand only) or any such amount as may be decided from time to time, shall be remitted by NSKFDC directly into the trainee's bank account as per training programme for the entire training period subject to fulfilling the minimum attendance criteria and other terms and conditions as prescribed in the training programme.

- B) Capital subsidy of Rs. 5.00 lakh for a maximum project cost of Rs. 15 lakhs will be admissible to identified manual scavengers and their dependents under the scheme. However, for projects of Self Help Groups/groups, the capital subsidy of Rs. 18.75 lakh for maximum project cost of Rs. 50 lakh.
 - The manual scavengers/dependents beneficiaries have option to select any viable income generating self employment project. Projects would not be imposed on the beneficiaries, rather their interest, experience and choice would be given due weightage in selection of project.
 - 2. The period of repayment of loan, including moratorium period will be five years for projects up to Rs. 5,00,000 and 7 years for projects above Rs. 5,00,000 with a moratorium period to start the repayment of loan will be up to 6 months.
 - 3. Credit linked up front capital subsidy will be provided to the beneficiaries in a scaled manner, as follows:

4. Beneficiaries who have successfully repaid earlier loans are eligible for loans subsequently.

5) SUBMISSION OF PROPOSALS

Proposal may be submitted in Proforma attached as **Annexure-I** by the interested institutions (Government/non-government), which are duly registered under any statute in India and which fulfill the following criteria are eligible for empanelment:-

<u>EMD:</u> Rs.5000/- (Rupees Five Thousand only) in the form of Demand Draft, from any of the Scheduled Bank drawn in favour of National Safai Karamcharis Finance and Development Corporation payable at New Delhi.

<u>Tender Fee</u>: Tender Fee including GST of **Rs.1,000/-** (Rupees One Thousand only) will be charged, which is to be submitted along with the Technical Bid in the form of Demand Draft, from any of the Scheduled Bank drawn in favour of National Safai Karamcharis Finance and Development Corporation payable at New Delhi. The MSME agency/units shall be exempted from submission of Tender Fee on production of proof of current registration certification from MSME/NSIC for the tendered item.

NOTE

- a) The EOI application without accompanying the requisite tender fee and EMD shall not be evaluated and shall be summarily rejected. The application document should be properly bound and secured before submission.
- b) Late submissions of applications (received after due date and time of submission of document) shall not be accepted under any circumstances.
- c) NSKFDC reserves the right to accept or reject any or all applications without assigning any reasons. No applicant shall have any cause of action or claim against NSKFDC for rejection of its/their application.
- d) EMD of unsuccessful bidders shall be refunded immediately after selection of the successful bidders.
- e) Intended applicants are required to watch the website of NSKFDC for all updates in connection with this pre-qualification viz. Addendum, Postponement of Submission schedules etc. NSKFDC shall not be responsible in any way on account of the intended applicant not noticing the updates.
- f) All communications between the Applicant and NSKFDC shall be conducted in writing.
- g) NSKFDC will respond in writing to any request for clarification received in writing from applicants before the last date of seeking clarification.

6) AMENDMENT OF PRE-QUALIFICATION DOCUMENT

- 6.1. At any time prior to the deadline for submission of applications, NSKFDC may amend the Pre-qualification Documents by issuing addenda.
- 6.2. Any addendum issued shall be part of the Pre-qualification Documents and shall be available on the website of NSKFDC.
- 6.3. To give Applicants reasonable time to take an addendum into account in preparing their applications, NSKFDC may, at its discretion, extend the deadline for the submission of applications

7. LANGUAGE OF APPLICATION

The application as well as all correspondence and documents relating to the Prequalification exchanged by the Applicant and NSKFDC, shall be in English or Hindi. Supporting documents and printed literature that are part of the application may be in another language, provided they are accompanied by an accurate translation of the relevant passages in English, in that case, for purposes of interpretation of the application, the English translation shall govern.

8. SIGNING OF THE APPLICATION AND NUMBER OF COPIES

- 8.1 The original of the application shall either be typed or downloaded from website www.nskfdc.nic.in or https://eprocure.gov.in or written in indelible ink and duly filled all the pages of the original copy shall be signed by a person or persons duly authorised to sign on behalf of the Applicant. All pages of the Pre-qualification documents, where entries or amendments have been made, shall be initialled and dated by the person or persons signing the application.
- 8.2 An authorized representative shall have the authority to conduct all business and incur liabilities related thereto for and on behalf of the organisation it represents, during the Pre-qualification and during contract execution.
- 8.3 All envelopes shall be titled "APPLICATION FOR SURVEY OF TARGET GROUP FOR SKILL DEVELOPMENT TRAINING AND CAPITAL SUBSIDY".
- 8.4 NSKFDC may, at its discretion, extend the deadline for the submission of applications, in which case all rights and obligations of NSKFDC and the applicants subject to the previous deadline shall thereafter be subject to the deadline as extended.

9 Procedure for Empanelment:

- 9.1 The proposals received would be scrutinized by NSKFDC and those organizations which qualify the eligibility criteria as mentioned in this document, shall be shortlisted and would be eligible for empanelment. Subsequently, the organizations which accept the Terms and Conditions including charges payable per survey may be empanelled.
- 9.2 The number of institutions to be empanelled shall be determined by NSKFDC based on the requirement. NSKFDC reserves the right to restrict the number of organizations at its discretion as per any criteria.
- 9.3 If the performance of the organization is not found satisfactory, NSKFDC reserves the right to cancel the empanelment of the institution.

10 Terms and Conditions for Survey

- 10.1 The applicant shall be responsible for obtaining relevant certificates or clearances from local civic authorities etc. NSKFDC shall extend necessary assistance wherever possible.
- 10.2 The empanelled institution shall go door-to-door at the houses/ basties of identified Manual Scavengers to collect data.
- 10.3 Any liability/claims arising due to organizing of project shall be that of the empanelled institution.
- 10.4 Empanelled institution will comply with other terms and conditions as per the EoI and such other terms as may be specified in the Sanction letter of NSKFDC or conveyed subsequently.
- 10.5 NSKFDC may, at its discretion, assign work and venues to any one or more of the empanelled institution/s depending upon its requirement.
- 10.6 The questionnaire for conducting the survey is at Part-IV. The organization is required to well acquaint its concerned staff about the delivery of the project. In this regard, NSKFDC or its authorized institution would provide necessary support wherever required.
- 10.7 The empanelled organization would prepare an action plan and keep NSKFDC updated of the progress made.
- 10.8 The organization will give complete publicity to NSKFDC and its schemes during the survey.
