The RFP document is available online and the RFP should be submitted online on website https://assamtenders.gov.in.
- 2. Date of release of Invitation for RFP through e-procurement: Please refer RFP
- 3. Cost of RFP Document: The tender cost is Please refer RFP
- 4. Availability of RFP Document and mode of submission: The RFP document is available online and bid should be submitted online on website https://assamtenders.gov.in. The bidder would be required to register in the web-site which is free of cost. For submission of RFP, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA). Aspiring bidders who have not obtained the user ID and password for participating in e-tendering may obtain the same from the website: https://assamtenders.gov.in. Digital signature is mandatory to participate in the e- tendering. Bidders already possessing the digital signature issued from authorized CAs can use the same in this tender.
- 5. Submission of Original Documents: The bidders are required to submit (a) Proof of online payment of RFP processing fee and bid security (EMD) for the amount and in the form provided in the RFP document or EMD Exemption proof and (b) Original copy of the technical bid to the Joint Director cum CHD, Women & Child Development, BTC, Kokrajhar, Assam on a date as per RFP, either by registered post or by hand, failing which the bids shall be declared non-responsive and summarily rejected.

RFP Summery

1. Purpose of RFP:

The purpose of this RFP is to seek participation of eligible organizations for Computer Training (6 months DCA Course) for girl students of BTR under Women & Child Development, BTC, Kokrajhar, and to this end, engage such organizations as Implementation Agency (IA) for Computer Training (6 months DCA Course) for girl students of BTR to improve the computer literacy among the girls of BTR as per the term of reference (TOR)given in this RFP document.

2. Overview and objective:

The proposal for Computer Training (6 months DCA Course) for girl students of BTR under Women & Child Development Department, BTC aims to provide computer training to girl student of 5 districts of BTR. Computers are an essential part of the modern era, and they are beneficial in various fields for various purposes. From education to the IT sector, libraries to railways, all the organizations have computers to serve the essential needs and goals. As computers have become the pinnacle of every field in present times, a person without the basic knowledge of handling computers is unable to perform to his/her full potential.

In the 21st century, every prominent job requires the employee to be endorsed with basic computer knowledge and it has become a basic amenity for the women job seekers to have the knowledge of computer for achieving their desired goals.

Benefits:

- 1. Six-months of Free Computer Training.
- 2. Valid government certificate of recognition.
- 3. Free soft skill and Entrepreneurship Training

3. Project Objectives:

The maximum numbers of Government/ private jobs need Computer literacy/ knowledge, where minimum 6 months diploma/ certificate in computer is mandatory. So for this, the candidates have to undergone paid diploma/ certificate courses in computer. After analyzing this scenario, the Women & Child Development, BTC wants to provide free computer courses along with diploma/certificate to girl students of BTR so that they can get Government as well as private jobs with an aim to empowering the women of BTR.

4. Program Outcome

- As Computer Certificate/ Diploma is very essential to apply for several Government examination so it will be helpful for them to get a job.
- Achievement of Digital Literacy for the girls and help in achieving Women Empowerment in BTR.
- Opening up of better job opportunities for the girls in BTR.
- Confidence to handle computers and cope up with the modern world.
- Progress in economic and social status of girls gradually leading to the social and economic development of entire BTR.

5. Submission Requirements:

Bidder shall submit their proposal in **online mode** in https://assamtenders.gov.in and a **Hard Copy** of proposal along with all necessary documents seal & signed by authorized signatory of the organization to be submitted in sealed envelope at **Office of the Joint Director cum CHD**, **Women & Child Development**, **BTC**, **Dimalgaon**, **P.O.** - **Titaguri**, **Kokrajhar**. The envelope shall bear the name of the Assignment on Top and Name & Address of the bidder in bottom.

6. Earnest Money Deposit (EMD):

The Earnest Money Deposit (EMD) will be Rs. 50,000.00 (Rupees Fifty Thousand) only for general caste (2%) and Rs. 25,000.00 (Rupees Twenty Five) only for Reserve Category (1%).

MSME registered firms/companies/ Organizations are exempted from EMD on production of valid MSME Certificate.

EMD to be refunded to the successful bidder after completion of the work. EMD will be refunded to all unsuccessful bidders within 30 days from last date of RFP submission.

7. Performance Security:

Within 10 (ten) days after the Supplier's receipt of Notification of Award, the Supplier shall furnish Performance Security 2% of the contract amount. Performance Security will be submitted in the form of Fixed Deposit pledge to the Joint Director cum CHD, Women & Child Development, BTC, Kokrajhar. Failure of the successful bidder to furnish the performance security as per provision of the bid shall constitute sufficient grounds for the annulment of the award and forfeiture of the bid security, in which event the Purchaser may make the award to the next lowest evaluated bidder or call for new bids.

9. Target achievement Schedule/ Timeframe

- > The proposal for Computer Training (6 months DCA Course) for girl students of BTR by the IA would be done within time and the duration of the program would be as per RFP.
- ➤ However, post empanelment of the IA, the expected start date is likely to be immediately after issue of work order.

10. Evaluation Criteria:

- a) In this part, the technical bid will be reviewed for determining the eligibility of the bidder for the Project and to ascertain Compliance of the Technical bids with the Tender terms and conditions, technical requirements and scope of work as defined in this RFP.
- b) In case of no response by the bidder to any of the requirements with regard to the contents of the Technical Bid, he shall not be assigned any marks for the same
- c) Technical bid of the bidder shall be opened and evaluated for acceptability. The bidders shall respond to the requirements as explained below for their evaluation with regard to experience and qualification. Also, the bidder shall refer and respond to all requirements as mentioned in the RFP document.
- d) The bidder would be technically evaluated out of 100 marks. All the bidders who secure overall minimum of 70% will be considered as technically qualified.

15. Resolution of Disputes

In case dispute arising between the Women & Child Development, BTC and the Agency, which has not been settled amicably, Arbitration proceedings will be held at Kokrajhar, Assam. The decision of the arbitrator shall be final and binding upon both the parties. All arbitration awards shall be in writing and shall state the reasons for the award. The expenses of the arbitration as determined by the arbitrator shall be borne by the Agency. However, the expenses incurred by each party in connection with the preparation, presentations hall be borne by the party itself.

All legal disputes between the parties shall be subject to the jurisdiction of the Courts situated in Guwahati or Kokrajhar, Assam.
